**Prisoner Transport:** On October 26, 2023, at 10:36 AM, a Parking Enforcement Officer responded to San Francisco SO jail to pick up a 36 year old male. The subject was arrested for an outstanding warrant held by Hercules PD. The subject was transported to the Martinez Detention Facility without incident. **(H23-01061)**

**Miscellaneous Information:** On October 26, 2023, at 11:41 AM, HPD officers were dispatched to Hercules Middle School for a report of an 11 year old male who was found writing a possible manifesto, and hit list, in his notebook. There were also drawings of guns, and concerning language, in the notebook. Ultimately, it was determined there was no credible threat against the school or its students at this time. The district security team also conducted a threat assessment. The juvenile's parents were notified and provided additional resources. A case was taken for documentation purposes. **(H23-01062)**

**Found property/Theft of a license plate:** On October 26, 2023, at 1:44 PM, HPD officers were notified of a stolen vehicle on northbound San Pablo Ave prior to Tsushima. An officer located the vehicle turning onto eastbound Hwy 4 from San Pablo Avenue. A stop was conducted on a black Lexus. The vehicle yielded on HWY4 just east of Sycamore Avenue and the 33 year old female driver was detained. Upon investigation, it was determined the VIN number of the stopped vehicle did not match the license plate of the stole vehicle. The VIN did match the black 2007 Lexus on scene. The driver stated she did not realize her rear license plate had been stolen and replaced with another plate. She was unsure if it was stolen in Pinole or San Francisco. The driver was released and a courtesy report was taken for the stolen license plate and entered into SVS. San Francisco PD was advised of the locate for the stolen license plate in their case. **(H23-01063)**

**Battery:** On October 26, 2023, at 5:52 PM, a parent reported his 15 year old daughter had been inappropriately touched, by a 15 year old male student, at Hercules High School. The incident occurred on Monday October 23, 2023. The officer is conducting a follow up investigation and there is an ongoing investigation at the school. **(H23-01064)**

**Mental Health Evaluation:** On October 26, 2023 at 6:29 PM, Officers were dispatched to the 1300 block of Chelsea for a report of a family disturbance. The reporting party advised her 16 year old son ingested an unknown number of suspected narcotic pills. The juvenile had left the residence prior to the Officers arrival. The subject was later located at 76 gas and was determined to be a danger to himself. The subject was transported to the Contra Costa Regional Medical Center for an evaluation and his mother was notified. **H23-1065**

**Mental Health Evaluation:** On October 26, 2023 at 9:25 PM, Officers were dispatched to the area of the Glenwood condos for a report of a female crying stating her son had fallen down and bleeding from his mouth. Officers contacted the 70 year old female reporting party, and a

28 year old male, in the parking lot. The male was heavily intoxicated but stated he was fine, though he had cuts to his face, legs, and hands. After speaking with the female, it was determined the male had made suicidal statements about shooting himself. The female stated the male had access to firearms, and showed Officers where the weapons were stored. Officer located two handguns and seized them for safekeeping. The male was transported to the Contra Costa Regional Medical Center for his injuries and a mental health evaluation. **H23-1066**

**Non-Injury Collision:** On October 29, 2023, at 9:14 am, Officers were dispatched to the intersection of Willow Avenue and Canterbury for the report of a vehicle collision. Upon arrival, it was determined a 53 year old female was driving eastbound on Willow Avenue towards Canterbury. Upon reaching the intersection, she was blinded by the sun and failed to stop at the stop sign controlling the four-way intersection. As a result, she collided her 2016 Lexus into 2016 Hyundai, driven by a 23 year old female. No injuries were reported and both vehicles were towed from the scene at the owners' request. **(H23-01067)**

**Missing Runaway Juvenile/Mental Health Evaluation:** On October 29, 2023 at 8:08 PM, Officers were dispatched to the 700 block of Turquoise Dr for a reported 14 year old female foster child who didn't return home. The subject was last seen at the residence at 4:15 PM. The subject's phone was off and she didn't say where she was going before leaving the residence. The subject previously ran away a month ago and was located at the Rodeo. Officers later located the subject walking on the center median of San Pablo Ave at Linus Pauling. The subject refused to get in the patrol vehicle to be transported back to her home. The subject's stepfather responded to the scene to pick her up, but she refused to go with him. The subject attempted to flee into the street and began kicking and punching Officers. No Officers were injured during the incident. The subject was determined to be a danger to herself, and others, and was detained for a mental health evaluation. While waiting for AMR, the subject repeatedly kicked the inside door panels of the patrol vehicle. The subject continued to resist and attempted to bite the paramedics while they were attempting to place her on the gurney. The subject was transported to the Contra Costa Regional Medical Center. **H23-1068**
