<u>Warrant Arrest:</u> On November 2, 2023 at 3:59 PM, an officer conducted a traffic stop on a 2003 Honda, in the Safeway parking lot, for an equipment violation. The 28 year old male driver, of Richmond, was driving on a suspended or revoked driver's license, and he had a warrant for his arrest out of Berkeley PD. The subject was arrested, cited, and released. The passenger took possession of the vehicle. **H23-01081** 

**<u>Child Endangerment:</u>** On November 2, 2023 at 9:01 PM, Officers were dispatched to the area of Sycamore Ave/Palm Ave for reported kids inside a minivan honking the horn and yelling for help. Officers located a Toyota Sienna stopped on the shoulder of the road. The 35 year old female driver was slumped over. She was breathing but unresponsive. The subject was given two doses of Narcan and became alert after the doses. AMR arrived and transported the female to a hospital. The four children (ages 8,4,1,1) were inside the Toyota unharmed. A family member arrived to pick up the children. Officers found a baggie containing a white powdery substance (a suspected controlled substance) near the driver seat. **H23-1082** 

<u>Mental Health Evaluation</u>: On November 2, 2023 at 11:12 PM, Officers were dispatched to the 100 block of Paradise for a mental health evaluation. The 30 year old male was determined to be a danger to himself and was transported to the Contra Costa County Regional Medical Center, by Ambulance for a mental health evaluation. **H23-1083** 

<u>Vehicle vs. Pedestrian</u>: On November 3, 2023, at 8:41 am, an officer was flagged down regarding a vehicle vs. pedestrian collision that occurred in front of the high school at 1900 Refugio Valley Rd. Officers located the Camaro on I-80 eastbound on-ramp from John Muir Pkwy. A was conducted and the subject was safely detained. After talking to the subject, it was stop determined he did not meet the criteria for a mental assessment. A handgun was located in a fanny pack near the driver's area. The subject was arrested and transported to the Martinez Detention Facility. **H23-01089** 

<u>Miscellaneous Information:</u> On November 4, 2023, at :53 pm, officers located a vehicle, wanted for Felony Evading out of South San Francisco, on Hercules Ave. near Village Parkway. The vehicle was a 2019 Black Harley Road King. The vehicle stopped in the 200 block of Glenwood. The 45 year old male driver, and registered owner, and his 40 year old female passenger, were detained without incident. The subjects were interviewed, and the information was given to South San Francisco PD The subjects were released at the scene. **H23-01090** 

**Mental Health Evaluation:** On November 4, 2023 at 11:23 PM, Officers were dispatched to the 700 block of Turquoise Dr for two runaway juveniles from their foster home. The 13 and 14 year old females were last seen running down Turquoise Dr. Officers located both juveniles. Both subjects began to run away once they saw the patrol vehicle. Both juveniles were non-compliant but were ultimately detained. Both juveniles were determined to be a danger to themselves and transported to the Contra Costa County Regional Medical Center, for a mental health evaluation. **H23-01091/H23-01092** 

**Domestic Violence:** On November 5, 2023 at 4:40 AM, Officers were dispatched to Burger King (828 Willow Ave) for a reported domestic disturbance. Officers determined the 29 year old female victim, and her 22 year old boyfriend had an argument which escalated and became physical. **H23-1093** 

Attempted Robbery: On November 5, 2023, at 1:38 pm, an Officer was dispatched to a phone detail regarding a reported "mugging" with a gun. The incident occurred near Chase Bank between approximately 12:30 pm and 12:40 pm. The reporting party was in their car in the parking lot and observed a male, with a gun, exit a vehicle. The male proceeded to approach a man and attempted to take the man's watch. The reporting party began to honk their car's horn to deter the suspect. The tactic apparently worked because the suspect reentered his vehicle and fled the scene. The reporting party spoke with the victim but did not obtain his contact information. At 1:38 pm, a 77 year old male called Dispatch and requested to speak with an Officer. It was determined the caller was the victim of the incident the reporting party had reported earlier. The victim stated he was in his car (Red Mini Cooper) in the Peet's Coffee parking lot, when a male, approximately 18 years, old with a thin build, exited a vehicle and approached him. The suspect then brandished a firearm and demanded

the victim give him his watch. The victim then heard a car horn honking and the suspect fled the area towards Safeway. The suspect was unsuccessful in taking the victim's watch. The victim was unable to obtain a plate for the suspect vehicle but last saw the vehicle driving toward Safeway...
