**Driving Under the Influence:** On November 6, 2023, at 1:07 pm, Officers were dispatched to Safeway (4080 San Pablo Ave) for the report of a vehicle collision with medical aid enroute. Officers located a 26 year old female, of Santa Rosa, in the driver's seat of her red 2011 Ford Fiesta. The Fiesta was stopped in a parking stall, and the front bumper of vehicle was pushed into the rear bumper of a red 2014 Cadillac, which was parked in the stall directly in front of the Fiesta. The collision appeared to be at slow speed and only minor damage was sustained by both vehicles. The 30 year old female owner of the Cadillac, and reporting party was not inside the Cadillac when the collision occurred. The reporting party returned to her vehicle after shopping and discovered the front end of the Fiesta pushed into the rear end of her Cadillac. The 26 year old female was sitting in the driver's seat of the Fiesta. During the Officer's contact with driver she displayed objective symptoms consistent with alcohol intoxication. Open bottles of alcohol were observed in plain view, scattered in the front passenger area of the vehicle. The bottles appeared to be mostly consumed. Based on the driver's objective signs of intoxication, the open containers of alcohol, and the vehicle collision, a DUI investigation was conducted. During the investigation, the driver was unable to perform any of the Standard Field Sobriety Tests, including the PAS (Preliminary Alcohol Screening) test. At the conclusion of the investigation, the driver was placed under arrest for DUI and was transported to HPD. A DUI blood draw warrant was authored and later approved by a judge. After the warrant was executed, the driver was cited and released to a responsible party. **(H23-01095/H23-01096).**

**Missing and Located Juveniles:** On November 6, 2023 at 9:04 PM, officers were dispatched to a call regarding two missing juveniles who had run away from their foster home in the 700 block of Turquoise Drive. Officers were familiar with the 13 and 14 year old female juveniles, from prior missing persons reports. Officers located both juveniles at Lucky and gave them courtesy transport back home. Both subjects were uninjured and did not seem to be in crisis or in need of any assistance. The reporting party is the primary guardian of both juveniles and officers relinquished custody to her. **H23-1097**

**Assault with a Deadly Weapon x 2, Felonious Criminal Threats x 2/ Mental Health Evaluation X 2: Assault with a Deadly Weapon x 2, Felonious Criminal Threats x 2/ Mental Health Evaluation X 2:** On November 6, 2023 at 9:59 PM, officers were dispatched back to the 700 block Turquoise Drive for a physical fight between the two females (suspects) the Officers had just returned home, and two other juvenile females (14 and 17 year old victims). The victims also lived in the foster home. The 13 year old suspect (S-A) began to punch and push the 14 year old victim. The 14 year old suspect (S-B) attacked the 17 year old victim with a full wine bottle, attempting to hit her in the head. The 17 year old victim ran and barricaded herself in a bedroom. S-B then grabbed a knife and gave it to S-A who was

still assaulting the 14 year old victim. S-A made multiple attempts to stab the 14 year old victim. Both suspects made several statements, heard by the two victims and their adult guardians, that they were going to stab and kill the victims. The male guardian struggled with the suspects in an attempt to stop the attacks but was unable to do so. The female guardian notified Hercules PD. S-A was heard stating she was leaving the home to get a gun. As she was leaving the home, officers arrived on scene and detained both suspects. No firearm was located. All parties were seen by medical personnel on scene. The victims sustained minor injuries from the assault. S-A had a sprained knee and S-B was uninjured. Both suspects were placed under arrest for Assault with a Deadly Weapon, and Criminal Threats. They were both non-compliant and in highly agitated states with officers. Both suspects were placed on a Mental Health Evaluation Hold after being determined to be a danger to others. The suspects were transported to the County Regional Medical Center. The hospital was notified of the pending criminal charges. Juvenile Hall was contacted and advised of the situation and pending charges. Child Family Services was contacted and advised of the circumstances. **H23-01098/H23-01099/ H23-1100**
