Trespassing: On November 9, 2023, at 1:16 pm, Officers were dispatched to the 200 block of Turquoise Dr. (Ohlone Elementary School) for a 61 year old female who on the school property looking for her son. The subject does not have any children attending Ohlone School. This was in violation of a served trespass order. The subject was arrested and transported to the Martenez Detention Facility. **H23-01103**

<u>Stolen Vehicle Recovery:</u> On November 11, 2023 at 4:47 AM, Officers received a FLOCK notification of a 2018 Kia Optima NB Willow Ave in the 1200 block of Willow Ave. Officers located the Kia, abandoned, in the 700 block of Sandy Brook. Video surveillance was obtained, and three suspects fled through the yard of a house in the 700 block of Sandy Brook. Officers checked neighboring yards and conducted an area check but were unable to locate the suspects. **H23-01105**

<u>Miscellaneous Information</u>: On November 12, 2023 at 12:03 AM officers were dispatched to a report of a physical fight between a husband and wife. The reporting party, a 27 year old female, called to report that she and her 28 year old husband had been drinking. They got into a fight. Officers responded to the scene and separated the parties. No injuries were observed or reported. Statements were taken from both sides as well as from multiple witnesses on scene. Officers determined no crime had occurred. The case was taken for documentation purposes. A family member drove the female subject from the scene in order to separate the parties for the night. <u>H23-01106</u>

Incident 168: On November 12, 2023 at 7:17 PM an officer stopped a white Nissan Quest van. Officers recognized the vehicle from a Solano County SO Track flyer regarding a criminal organization placing skimmers on ATMs. The occupants were identified as a 36 year old male, and a 36 year old female. A consent search of the vehicle was conducted. No probable cause to arrest was established and the subjects were released.

Possession of Methamphetamine, Possession of Drug Paraphernalia, Possession of Counterfeit Currency: On November 13, 2023 at 12:59 AM an officer conducted a vehicle check on a blue 2000 Volkswagen Passat parked to the rear of Big Lots. Officers recognized a 50 year old male, digging through the dumpster and throwing trash onto the ground. The subject was detained when a bag of suspected Methamphetamine, and a suspected Methamphetamine pipe, were observed in plain view in his car. A Records check determined the subject is on searchable probation out of Solano County. A search of the vehicle was conducted which yielded several counterfeit hundred dollar bills concealed within the subject's backpack. Officers were dispatched to several calls recently where the subject was attempting to pass counterfeit bills as real currency. The subject was placed under arrest for the drug charges and for the counterfeit currency. The subject was cited and released on scene.. <u>H23-01108</u>
