<u>Fraud:</u> On November 16, 2023, at 11:28 am, an officer was dispatched to the Lobby of the Police Department for a Fraud Report. The victim stated on October 25, 2023 he received a letter from his Life Insurance company stating that a large cash withdrawal was taken from his life insurance without his knowledge. The victim contacted the Insurance legal department, and they confirmed the money was taken and transferred to accounts out of state. <u>H23-01117</u>

The husband called and said his 61 year old wife was having thoughts about hurting herself. Officers determined the wife was a danger to herself and needed a mental health evaluation. <u>Warrant Arrest Transport:</u> On November 17, 2023, at 9:00 am, an officer picked up a 56 year old female, for an outstanding Hercules warrant, from Santa Rita County Jail. The subject was transported to the Martinez Detention Facility. <u>H23-00298</u>

<u>Warrant Arrest</u> On November 17,2023 at 8:21 PM officers contacted a 31year old male to the rear of Big Lots. The subject was found to have warrants out of San Francisco, and the subject was arrested and transported to the Martinez Detention Facility. **H23-01120** 

<u>Warrant Arrest:</u> On November 18, 2023, at 3:23 pm, officers were dispatched to Refugio Valley Rd. and Sycamore Ave. for a welfare check on a male who panhandling in the intersection. Officers contacted a 35 year old male, out of Fairfield, and determined he had a warrant for out of Los Angles SO. The subject was arrested transported to the Martinez Detention Facility. <u>H23-01121</u>

Felon in Possession of a Firearm, Possession of a Stolen Firearm x 2, Possession of Firearm with prior Drug Convictions, Possession of Firearm with Prior convictions of Crimes Against Persons x 2, Possession of Concealed Firearm in a Vehicle x 2, Felon in Possession of Ammunition, Possession of Counterfeit Driver's License x 2, Warrant Arrest x 2: On November 19, 2023 at 8:15 PM officers were dispatched to 4080 San Pablo Avenue for a report of an armed robbery suspect (from another jurisdiction) parked in front of Chase bank. The 51 year old female reporting party advised she is the owner of a cannabis dispensary company. One of its delivery drivers, a 25 year old male, was robbed and assaulted at gunpoint and at knife point. The incident occurred in Modesto on November 18, 2023 at approximately 5:00pm. A tracking device, which was inside the stolen Marijuana container, led the reporting party to Hercules. After confirming, via her tracker, that the stolen device was inside a white Toyota Highlander the reporting party called HPD. Officers arrived and detained the 33 year old male driver, and the 41 year old female. A search of the vehicle was conducted. Officers located the stolen tracking device; several bags of Marijuana,

bearing the cannabis company name; a ski mask; a knife; and a handgun. A records check was conducted, and the firearm was reported stolen out of Mississippi. The firearm was located concealed in the female subject's purse. The purse was hidden underneath the driver's seat, where the male was sitting. The robbery victim was contacted and responded to the scene. The victim positively identified both the male and female as the suspects who robbed him. Modesto PD obtained two warrants for the subjects and faxed the warrants to Hercules PD. The subjects were arrested for the firearms related charges and the warrants. Further search of the vehicle produced multiple false driver's licenses bearing both subjects pictures. Counterfeit debit and credit cards bearing subject's names were located along with cards containing other victim's names. The items were seized as evidence. Both subjects were transported to the Martinez Detention Facility and their vehicle was towed. **H23-01123**
