**Stolen Vehicle:** On November 20, 2023, at 6:24 am, an Officer was dispatched to the 100 block of Paradise Dr for the report of a stolen vehicle. The reporting party said between 3:00pm yesterday and 6:20 am today, an unknown suspect stole her green Honda Civic. The Civic was parked in her designated parking stall, located on the apartment complex's premises. No one has permission to have possession of her vehicle. **(H23-01124)**

**Minor in Possession of Marijuana; Possession of Marijuana (more than 28grams); Possession of Marijuana for Sales; Possession of Marijuana for Transport, Import, Sell; Possession of a Controlled Substance:** On November 20, 2023, at 10:33 am, an Officer conducted a traffic stop on a gold 1994 Infiniti Q45, on San Pablo Avenue near Safeway, for vehicle code violations. The driver was identified as a 16 year old male of Vallejo. Upon contacting the subject, the Officer smelled the strong odor of both fresh and burnt marijuana emitting from inside the vehicle. The Officer noticed a partially smoked, extinguished, "blunt" in the ashtray located along the center console of the vehicle. The "blunt" was suspected to contain Marijuana. Due to the subject's age, a probable cause search of the vehicle was conducted. The Officer located approximately three quarters of a pound of suspected marijuana; a weight scale; numerous marijuana packaging materials; and 15 packages containing vape pens, each filled with approximately 1.0 gram of suspected marijuana concentrates. In addition, over \$1,000 of US currency was found on the subject's person. The subject was arrested and transported to the Juvenile Hall in Martinez. **(H23-01126)**

**Assault with a Deadly Weapon, Felonious Criminal Threats:** On November 20, 2023 at 7:11 PM an officer was dispatched to the 100 block of Stanley Court for a report of an assault with a deadly weapon which had occurred November 19, 2023. The 17 year old male victim told his father a McDonald's employee threatened him and ran him over with a 2005 black Acura TL. The father called the Police. Officers contacted the victim. The victim knows the suspect, and identified him as a 21 year old male. The victim stated he and the suspect had a verbal argument at the McDonald's in Hercules. The suspect got into his Acura and threatened to run over the victim with his car. The suspect drove away from McDonalds, made a U-turn and accelerated his vehicle towards the victim. The victim said the suspect intentionally struck him, in the legs, with his vehicle. The victim suffered bruises and abrasions to his legs. A witness to the assault was contacted and corroborated victim's statement. Officers located the suspect vehicle parked in the 100 block of Watermark Terrace. The front end of the vehicle had scratches, and damage consistent with the victim's injuries and statement. The suspect was contacted and placed under arrest without incident and transported to the Martinez Detention facility. **H23-01128**

**Found Property, Stolen Plates report:** On November 20, 2023 at 8:25 PM an officer was dispatched to the 200 block of Compass Point Court for a report of a stolen license plate. An unknown suspect, at an unknown time, stole the victim's license plate. The suspect replaced the license plate with another license plate belonging to a 2012 Mercedes Benz registered to an address in Oakland. The Mercedes plate was removed and taken as found property. The Mercedes plate had not been reported stolen. The Lexus plate was entered into SVS as stolen..**H23-01129**
