**Stolen Vehicle Recovery, Parole Violation:** On November 21, 2023, at 10:14 am, a parking enforcement officer located a reported stolen vehicle (silver 2015 Toyota Prius) parked along the curb on Refugio Valley Rd near Malibu Dr. As the parking enforcement officer went to examine the vehicle, he discovered it was occupied by a 30 year old male, with a beard, and wearing a black hoodie and faded blue jeans. The suspect exited the Prius and began walking away from it. The parking enforcement instructed the subject to stop, but he ignored the commands. The subject was last seen on Malibu Dr. HPD units arrived, and a perimeter was set. The HPD drone was deployed, and a search for the subject ensued. Officers were not able to locate the subject. The Prius was removed from SVS and towed. Residents in the area were provided with a description of the subject and requested to be on the lookout for him. At 12:23 pm, a resident called to report that they observed the subject walking down Midship Dr. Officers responded to Midship and began searching for the subject. A perimeter was reestablished, a drone was redeployed. During the search, it was determined the subject was associated with a residence in the 100 block of Midship. Officers obtain the code to the front door from the homeowner, who also granted officers permission to enter and search the home. A call out, at the front door, was conducted. and the subject came to the door and was detained without incident. The parking enforcement officer positively identified the subject as the suspect he saw walking away from the Prius. The subject was arrested and determined to be on active parole. A compliance search of his bedroom was conducted, and paperwork associated with the Prius was located. The subject was transported to the Martinez Detention Facility. His parole officer was contacted, and a parole hold was granted. **(H23-01131)**

**Warrant Arrest:** On November 21, 2023 at 1:06 AM an officer conducted a vehicle check on a 2005 Black BMW sedan, parked in front of Share Tea, occupied by 3 transients. One of the transients was identified as a 40 year old male who was determined to have a felony warrant for his arrest out of Solano County. The subject was arrested without incident and transported to the Martinez Detention Facility. **H23-01132**

**Warrant Arrest:** On November 22, 2023 at 5:36 AM an officer observed a subject loitering at the Shell gas station. The officer conducted a Records check on a 2005 beige Honda Accord which was associated to the subject. The registered owner of the vehicle was determined to be a 31 year old male. A records check determined the RO had a misdemeanor arrest warrant. The officer obtained a Cal Photo of the subject which matched the driver. An investigative stop was initiated, and the wanted subject was identified as the driver. The warrant was confirmed, and the subject was placed under arrest and transported to the Martinez Detention Facility. **H23-01133**
