Stolen Plate and Found Property: On November 30, 2023, at 12:16 pm an officer was dispatched to Ohlone Elementary School for a theft report. The victim stated an unknown suspect stole the front plate off her vehicle and replaced it with another plate. The plate taken off the victim's white Toyota Corolla. It was replaced with a plate reported lost or stolen out of Berkeley. The victim's plate number was entered into the Stolen Vehicle System, and the other plate was cleared and returned to DMV. **H23-01164**

Theft by False Pretenses: On November 30, 2023, at 12:45 pm officers were dispatched to the 200 block of Violet Rd. for a possible missing person report. The adult reporting party said her 42 year old mother was supposed to be home, from her job site in Napa, around 11:15am. The mother did not come home and was not answering her phone. While officers were speaking with the daughter mother arrived home. The mother was not answering her phone because she was talking with an unknown suspect who claimed to have abducted her daughter (the reporting party). The investigation determined the suspect "spoofed" that daughter's phone number and called the mother demanding money to let the daughter go. The mother wired the money she had to a given address in Mexico. The suspect stayed on the line trying to get the mother to send more money. The officer took the phone from the mother and spoke to the suspect. He was unpleasant and hung up. The kidnapping was unfounded. A case was taken for Theft. **H23-01165**

Shoplifting: On November 30, 2023, at 2:18 pm officers were dispatched to Big Lots for theft that had occurred approximately five minutes prior. The suspect left with \$70.00 in merchandise. No suspect was located in the area check **H23-01166**

Miscellaneous Investigation: On November 30, 2023, at 3:23 pm an officer responded to the 200 block of Turquoise Dr to the Ohlone Childcare for a miscellaneous report about threats made by a nine-year-old student. **H23-01167**

Warrant Arrest: On November 30, 2023 officers were on patrol, in Concord, working a County wide Vehicle Theft Suppression and Enforcement detail. At 7:09 PM officers contacted a 25 year old male at the Concord Home Depot located at 2090 Meridian Park. Resisting/ Warrant Arrest: On November 30, 2023 at 10:56 PM an officer attempted to stop 33 year old male pedestrian, from Palm Desert, and he failed to comply and resisted arrest. The Officer was able to subdue the subject and detain him. The subject had two warrants out of Santa Cruz County. Court Order Violation: On December 1, 2023 at 12:41 AM officers responded to the 2200 block of John Muir PKWY for a subject who was harassing his ex-girlfriend. The 33 year old female, from Hercules, stated she was receiving threatening text from her 37 year old ex-boyfriend, In the text he stated he was at the reporting party's apartment and was going to harm her. Officers did an area check with negative results. The reporting party has an active order restraining the male subject from contacting her in person or via electronic communication. **H23-01170**

Mental Health: On December 1, 2023 at 8:11 PM officers responded to the 1500 block of Swallow Way for a subject having a mental episode. The 28 year old male, from Hercules, was determined to be a danger to himself and others and was transported to the Contra Costa Regional Medical Center by AMR. **H23-01171**

Domestic Violence: On December 2, 2023 at 1:52 AM officers responded to the 2100 block of Clark Street for a disturbance. The 43 year old female reporting party, from Hercules, stated her 47 year old ex-boyfriend, from San Francisco, was trying to kick down her door. Officers arrived and contacted the male subject and detained him without incident. The subjects were having a verbal argument when the male began slapping the female and holding her down. The female denied a protective order and medical attention. The male was arrested and transported to the Martinez Detention Facility. **H23-01172**

Vehicle Tampering: On December 2, 2023 at 1:13 PM, an officer was dispatched to a report of an auto burglary in the area of Sycamore Ave at Taraya Terrace. The reporting party stated, sometime between 10:30 PM last night and 6:45 AM this morning, her 2003 Infinity FX45 got a hole in her door. Upon investigation it was determined that an unknown suspect drilled out the keyhole, damaging the door handle and there was no property loss. **H23-01173**

Mental Health Evaluation: On December 2, 2023 at 8:06 PM officers responded to the 1500 block of Swallow Way for a 28 year old male who reportedly stabbed a caregiver. Upon arrival Officers detained the subject without incident- The 58 year old male care giver stated the subject was released from a hospital that morning and was still acting erratic today. The caregiver was putting groceries away when the subject grabbed a kitchen knife and swung it at the caregiver. The action was described as playful, and without any malicious intent. The subject immediately put the knife down and apologized. The caregiver had a small one-inch scratch on his thumb and declined medical attention. The caregiver stated he was not in fear for his safety and didn't desire prosecution. The subject was determined to be a danger to himself and others and was transported to the Contra Costa Regional Medical Center by AMR. **H23-1174**

Warrant Arrest X2: On December 3, 2023 an Officer conducted a pedestrian stop, in the 800 block of Willow Ave. The 27 year old female, of Antioch, had a no-cite warrant out of Walnut Creek PD. Th subject arrested. Officers determined the female's 34 year old male companion, of Fairfield, was currently at the 76 Gas Station. The male subject had two no-cite warrants out of Sonoma County. Officers contacted the male. He was arrested without incident. Both subjects were transported to the Martinez Detention Facility il. **H23-1175 / H23-1176**

Located Missing Person: On November 03, 2023, at 2:40 pm, Dispatch advised of a missing person's vehicle, a red 2010 Chevrolet HHR; was traveling on eastbound I80 at Appian Way in Pinole. The 56 year old female missing person, of Vallejo, was reported missing to Vallejo PD in July of this year by her husband. An Officer located the vehicle traveling on eastbound I80, just prior to Cummings Skyway. The Officer conducted a traffic stop on the vehicle

yielded at Cummings Skyway. Both the subject, and her husband, were in the vehicle and appeared to be++

in good health. It was determined the female returned home but the husband never notified law enforcement to have her removed from the Missing and Unidentified Persons System.
