Stolen Vehicle On December 14, 2023 at 11:35 PM an officer responded to the 100 block of Decatur Court for a report of a stolen Mercedes Benz EQS 580. The 31 year old male victim stated he left for vacation on December 10,2023 and when he returned today, he found his vehicle was missing **H23-01210**

Stolen Vehicle: On December 15, 2023, at 1:23 pm, a resident called to report his vehicle had been stolen. The victim stated he parked his Red 2021 Chevrolet Camaro with a black hood, in the area of John Muir Parkway at Tioga Loop around 2:00 am and when he returned to the location at approximately 12:30 pm his vehicle was gone. **H23-01211**

Possession Of controlled substance and Ammo: On December 16,2023 at 3:24 AM an officer checked on a 1998 Lexus sedan, parked at the Grove Church in the 900 block of Willow Avenue. Officers contacted a 34 year old female, from Concord; and a 25 year old male, from Vallejo. The male is on searchable probation and was in possession of suspected methamphetamine, and ammunition. The male subject was arrested and transported to the Martinez Detention Facility. The female was released on scene. **H23-01212**

Stolen Vehicle: On December 16, 2023 at 7:46 AM an officer was dispatched to the 600 block of Forest Run for a stolen vehicle report. The 34 year old male victim advised his red 2016 Hyundai Elantra had been stolen between 5:00 PM on December 15,2023 and 7:46 AM on December 16, 2023. The Hyundai was last recorded on FLOCK at 7:15 AM on December 16, 2023 traveling North on San Pablo Avenue at Hercules Avenue. No suspect information was available. **H23-01213**

Warrant Arrest: On December 16, 2023 at 12:03 an officer observed a 2003 black Mercedes SUV with no license plates. A traffic stop was conducted for vehicle code violations. The 42 year old male passenger was determined to have an outstanding warrant for a probation violation. The subject was placed under arrest and transported to the Martinez Detention Facility for booking. **H23-01214**

Battery, Criminal Threats, Vandalism: On December 17, 2023 at 9:53 AM officers were dispatched to a physical fight at the Safeway gas station. By the time officers arrived, the suspects had fled the scene. The 57 year old male victim (V-1) advised he had gotten into a verbal altercation with an unknown adult female (S-1.). S-1 called an unidentified adult male (S-2) into the store to confront V-1. S-2 punched the V-1 in the face, with a closed fist, knocking V-1 to the ground. S-2 then stood over and threatened to continue to assault the V-1. S-1, and S-2, walked back to their black 2013 Nissan Maxima. A 55 year old female (V-2) attempted to take a picture of the license plate. S-2 struck the V-2 in the hand, with an open handed slap, to prevent her from taking the picture. The phone fell to the ground and S-2 picked it up threw the phone across the parking lot, damaging the phone. S-2 threatened V-2 and V-1 by stating he would return to find them with his "boys. **H23-1215**
