**Warrant Arrest:** On December 18, 2023 at 5:01 PM officers were dispatched to 76 gas station, in the 800 blk of Willow Ave, for a report of a homeless male requesting to go to jail. The 42 year old male called dispatch asking to be arrested. A records check determined he was clear of warrants but was on active Parole from the California Department of Corrections and Rehabilitation (CDCR). The subject was released. Several hours later, the subject cut off his ankle monitor and CDCR issued a Parolee At Large Warrant. Officers located the subject loitering at a restaurant, in the 800 block of Willow Ave, and placed him under arrest without incident. The subject was transported to the Martinez Detention Facility. **H23-01217**

**Hit and Run with Injuries:** On December 18, 2023, at approximately 6:41 PM, Officers were dispatched to a collision that occurred on San Pablo Ave near the Safeway entrance. Prior to the officers' arrival one of the parties left the scene. Officers arrived and the investigation determined a 21 year old male, driving 2005 Honda Civic, was turning left into Safeway on a green light. A Silver Toyota Prius, traveling northbound on San Pablo Ave, ran the solid red light, colliding with the Honda. Initially the driver of the Prius pulled over. The adult female driver exited the driver's seat and spoke with male driver of the Honda. The female then reentered her Prius and left the scene without identifying herself or exchanging information. A 20 year old female passenger in the Honda, was transported to hospital for a complaint of pain. **Case 23-01218**

**Runaway/Missing Juvenile:** On December 18, 2023, at approximately 7:38 PM, Officers were dispatched to the Glenwood condo development for a report of a runaway 13 year old female. An Officer learned earlier in the day the juvenile, and her mother, got into an argument that involved a police response to defuse the situation. After the incident the mother left briefly. When she returned, she could not locate her daughter. The mother spoke with one of juvenile's friends who stated they thought the juvenile was in Oakland but did not know where. The juvenile was entered into the Missing and Unidentified Person's System. **Case 23-01219**

**Domestic Violence:** On December 18, 2023, at approximately 11:19 PM, Officers were dispatched to the 100 block of Copper Beech Glen for a report of domestic violence. Officers arrived and separated the parties on scene. The investigation determined a 56 year old male was the primary aggressor during an argument/altercation with the 56 year old female victim. The male was arrested and booked at the Martinez Detention Facility. **Case 23-01220**
