Aggravated Battery with Loss of Consciousness: On December 20, 2023 at 9:05 AM officers were dispatched to the 100 block of Coventry for a report of a physical fight between family members. Officers were advised the 24 year old male victim had been punched by his 20 year old brother. The victim fell to the ground losing consciousness. Officer detained the suspect without incident. An ambulance was called to the scene to evaluate the victim who complained of head and jaw pain and seemed disoriented. The victim was transported to a hospital. The suspect was placed under arrest and transported to the Martinez Detention Facility. **H23-01225**

Prisoner Transport: On December 20, 2023 at 9:08 AM an officer picked a 40 year old male, for an outstanding Hercules warrant, from Marin County Jail The subject was booked at the Martinez Detention Facility. **H23-01226**

Occupied Stolen Vehicle Recovery, Evasion, Assault With a Deadly Weapon on a Police Officer: On December 20, 2023 at 12:03 PM an officer observed a stolen gray 2013 Hyundai Sonata driving North on San Pablo Avenue Near John Muir Parkway. The officer advised Hercules units of the stolen Hyundai and its location. Another officer was at John Muir Parkway at San Pablo Avenue, on an unrelated traffic stop. The second officer observed the stolen Hyundai which began to accelerate away, at a high rate of speed, from the officer trailing it. The second officer was able to successfully deploy stop sticks, deflating three of the Hyundai's tires. Both officers trailed the stolen Hyundai East on Highway 4 reaching speeds ranging from 15 miles per hour to 60 miles per hour. The Hyundai was unable to evade effectively or quickly due to 3 tires being deflated. The integrity of the Hyundai's rims began to fail causing the vehicle to drive erratically and at even slower speed. The driver lost control of the Hyundai and spun-out facing West on Eastbound Highway 4. The driver attempted to continue evading and drove, the wrong way, directly towards an officer who was stopped. The Hyundai struck the officer's vehicle causing minor damage to the front, push bumper. A stop was conducted Highway 4 East prior to the Alhambra exit. The driver was detained without incident. The driver was determined to be a 16 year old male. The Hyundai had just been stolen in Richmond several hours prior. The juvenile appeared to be uninjured, but was evaluated at the county hospital prior to being transported to Juvenile Hall. The officer did not sustain any injuries. **H23-01227**
