Auto Burglary, Vehicle Tampering: On April 4, 2024 at 3:00 AM an officer conducted a pedestrian stop on a suspicious male who appeared to be prowling near the 700 block of Turquoise Drive. The 47 year old male was contacted. Drug paraphernalia was observed, in plain view, inside the subject's tan 2001 Acura MDX. a health and safety compliance search was conducted. No apparent evidence of a crime was observed at that time. The subject was admonished to leave the area. As the subject was driving away, an adult female flagged down officers near the 700 block of Turquoise Drive. She stated her 2006 Toyota Camry had just been burglarized and appeared as if it had been ransacked. An officer located the previously contacted male. He was driving up and down Willow Avenue.
