**Miscellaneous Information:** On April 4, 2024, at 8:05 PM officers were dispatched to a telephone detail with an FBI agent. The Reporting Party (RP), 58 year old female of Sacramento, reported to FBI agents in San Francisco that her 16 year old son was being sexually and physically abused by his father, 59 year old male subject (SUB), in Hercules. FBI agents forwarded the information to Hercules PD. Officers conducted follow up but were unable to contact the RP or any family members who could corroborate the story or provide a statement. Officers attempted to contact SUB and his son at their home on Tsushima Street. SUB refused to open the door or give a statement to police. SUB was highly uncooperative. The case is pending further information from involved parties. **H24-00321**

**Driving Under the Influence of Alcohol:** On April 5, 2024, at 3:08 AM an officer conducted a traffic enforcement stop on a black Kia Optima for various vehicle code violations. The Kia was traveling in excessive speeds of 80 miles per hour on San Pablo Avenue at John Muir Parkway failing to maintain its lane while driving with its headlights off. The officer stopped the Kia and contacted an irate and uncooperative 32 year old female of Hercules. The subject (SUB) had a cup of Tequila in her driver side door panel and a half empty bottle of Tequila on her floorboard. SUB refused to follow all officer commands and instructions; she was escorted out of the vehicle and promptly detained in handcuffs. Due to SUB's combative nature, Standard Field Sobriety Tests were not able to be performed. SUB refused the Preliminary Alcohol Screening tests and chemical tests. A DUI blood draw warrant was authored and executed at Hercules PD. SUB was finally compliant. The Kia was towed from the scene. SUB was cited and released and given a courtesy transport to her home in Hercules. **H24-00322**

**Mental Health Evaluation Hold:** On April 5, 2024, at 8:05 PM officers were dispatched to a suicide attempt in the 2000 block of Bayfront Boulevard. The reporting party advised his girlfriend, 26 year old female subject (SUB), had ingested unknown pills in a suicide attempt. Officers responded and contacted an alert and coherent SUB. SUB confirmed that she told her boyfriend that she was suicidal but denied ingesting the pills. Officers located a half empty bottle of prescribed Oxycodone in SUB's apartment. SUB was determined to be a danger to herself and was placed on a mental health evaluation hold. SUB was transported to the Contra Costa County Regional Medical Center. **H24-00324**

**Driving Under the Influence of Alcohol:** On April 6, 2024, at approximately 1:00 AM, an officer observed a brown 1992 Ford F250 driving west on Willow Avenue. The Ford parked at 800 Willow in the park and ride. The officer returned later, and the same Ford was still parked and occupied at 3:07 AM. A records check of the Ford determined its registration was expired as of 2021. The Registered Owner of the vehicle was determined to be a 55 year old male subject (SUB), of Berkeley, who had a suspended driver's license for multiple prior DUI's. The officer conducted a suspicious vehicle check and observed SUB passed out in the driver seat with a can of beer in the center console. The officer awoke SUB who admitted to

drinking alcohol and driving. The subject was given the Standard Field Sobriety Test; and the Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purpose of driving. SUB was placed under arrest for Driving Under the Influence. A blood draw was performed, and SUB was cited and released to a responsible party. The Ford was left parked at 800 Willow Avenue. **H24-00325**

**Prisoner Transport:** On April 6, 2024, at 10:21 AM a 56 year old male was picked up and transported from Santa Rita Jail to the Martinez Detention Facility for a Hercules warrant. **H24-00326**

**Vehicle VS Pedestrian:** On April 7, 2024, at 12:39 AM an officer witnessed a black 2004 Honda Pilot inadvertently collide with a bicyclist on Willow Avenue near the 76 gas station. The bicyclist was identified as 37 year old male (Party 2). Party 2 was uninjured and declined to be transported after being evaluated by AMR. The driver of the Honda, 47 year old male (Party 1), was uninjured and declined medical attention. Preliminary Standard Field Sobriety Tests were conducted, and Party 1 did not show any signs of being under the influence. Both parties were provided a case number and released from the scene. **H24-00327**

**Possession of Methamphetamine/ Probation Violation:** On April 7, 2024, at 2:29 AM an officer observed a transient wearing a ski mask and riding a bicycle on Willow Avenue. The officer conducted a traffic stop on the transient for vehicle code violations. The transient was identified as 50 year old male. The subject (SUB) was detained, and a probation search was conducted. SUB was found to be in possession of suspected Methamphetamine. SUB was cited and released at the scene. **H24-00328**

**Driving Under the Influence of Alcohol/DUI Collision Without Injury:** On April 7, 2024, at 2:39 AM officers were dispatched to a collision on John Muir Parkway at Tioga Loop. The Reporting Party (RP) advised a 1996 green Ford Mustang was involved in a solo vehicle collision in front of his home. The RP advised several people were on scene pulling the driver out of the Ford and were attempting to flee the scene. Officers arrived on scene and observed a small crowd of people. The crowd advised the driver fled on foot towards Bayfront Boulevard. Officers determined the crowd were friends of the driver. An officer looked inside a nearby vehicle belonging to one of the friends and observed an intoxicated individual attempting to hide inside. A 25 year old male subject (SUB) of Vallejo was contacted. A records check of the Ford determined SUB was the registered owner. When contacted by officers, SUB admitted to drinking and driving. SUB was cleared on scene by AMR and declined to be transported. SUB had no visible injuries, denied being injured, and had no complaint of pain. The subject was given the Standard Field Sobriety Test; and the Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purpose of driving. SUB was placed under arrest for Driving Under the Influence. The Ford was towed from the scene. No vehicles or pedestrians were involved. SUB performed a breath test at Pinole PD. SUB was cited and released to a responsible party. **H24-00329**

**DUI Collision Without Injury:** A separate case was taken for the collision portion of the DUI collision. **H24-00330**
