## CAMP POLICIES ACKNOWLEDGEMENT AGREEMENT Check -after reading. O Credit Card Payment: After you make your 1st payment you must pay each block one week prior to the new block starting. You can pay by filling out a credit card sheet or online/over the phone. If the card is declined an NSF charge fee of \$36.00 will be charged. Call the CSC at 510.799.8291 with new credit card information. Plus, a 24-hour mail slot for checks only. If payment not paid by due date, we would need to move to the next person on waiting list. O Billing Issues: The City of Hercules will not contact any other person except the parent or guardian on the registration form regarding billing issues. Community Swim Center hours Monday-Thursday 8:30am-5:00pm, contact number 510.799.8291. O Enrollment: is contingent upon our ability to staff the blocks, meet the minimum age-appropriate enrollment numbers, and the completion of all registration paperwork, including payment in full for each block. O Cancellation: will not be permitted during the three-week block sessions nor refunds. A medical exception may be made on a per case basis. If we cancel the program, you will receive a credit/refund. • Late Pick-Up: There is a \$3 per minute charge for picking up your child (ren) past their scheduled time. O Transfer /Refunds: No transfer policy due to very limited enrollment space. Camps will be based on a 1st come and 1st serve policy. Refunds there will be no refunds unless the City must cancel because we cannot staff, or do not get the enrollment minimums. In which a full refund will be given. O Electronics: No electronics of any kind are allowed in our Camp Programs.
