**Stolen Vehicle:** On April 18, 2024, at 8:05 AM an officer responded to Village Pkwy and N Wildwood for a stolen vehicle report. The victim stated he parked his 2018 Ford Fusion on Village Pkwy on April 15, 2024. When the victim returned to his vehicle today, he noticed it was missing. The vehicle was entered into the Stolen Vehicle System. **H24-00357**

**Shoplifting:** On April 18, 2024, at 3:46 PM officers responded to Big Lots at 1551 Sycamore Avenue for an adult female who stole from the store. The female fled in a gray Acura Sedan towards Roundtable. The manager elected to press charges and believes they can identify the suspect if located. **H24-00358**

**Shoplifting** On April 19, 2024, at 2:45 PM officers were dispatched to Big Lots at 1551 Sycamore Avenue for a subject shoplifting. The subject was identified as 32 year old male from Fairfield. The subject (SUB) fled in a gray Mazda CS30 and was located and stopped on the eastbound I-80 on-ramp from John Muir Pkwy. SUB was identified by the manager and was arrested and transported to Martinez Detention Facility. **H24-00360**

**Motorcycle Collision with Injury:** On April 19, 2024, at 11:26 PM, an officer located an injured biker lying in the roadway on Willow Avenue near Sycamore Avenue. The biker, 21 year old male of Hercules, appeared to have just crashed his street bike. The subject (SUB) had visible injuries and complained of pain. Hercules officers began to render aid and control nearby traffic. The 2003 Honda street bike sustained heavy damage. Paramedics responded to the scene and evaluated SUB. SUB advised officers he was speeding and struck a curb on Willow Avenue which caused him to lose control. SUB was transported to the hospital with minor injuries. SUB called a friend to collect his bike from the scene. **H24-00361**

**Trespass:** On April 20, 2024, at 8:48 AM officers responded to 76 Gas Station at 828 Willow Avenue for a subject refusing to leave and harassing customers. The subject was identified as a 31 year old male, of Hercules, and was on the trespass log for this location. A complainant's arrest form was completed, and the subject was arrested and transported to Martinez Detention Facility. **H24-00362**

**Injury Collision:** On April 20, 2024, at 5:26 pm, officers were dispatched to an injury collision in the 1800 block of Lupine Rd. Officers arrived on scene and located a 2014 Toyota Sienna that had collided into a parked Toyota Prius. It appeared the driver of the Sienna fell asleep

and collided into the Prius. The driver and front passenger were transported to a local hospital for complaint of pain. The Sienna was towed. **H24-00363**

**Domestic/Resist/Delay:** On April 20, 2024, at 6:08 pm, officers were dispatched to the 200 block of Glenwood for a domestic dispute that turned physical on the phone with dispatch. Officers arrived on scene and contacted and separated the 54 year old male subject (SUB 1) and 45 year old female subject (SUB 2). Officers determined that SUB 2 was the dominant aggressor and she was arrested for Domestic Battery and False Imprisonment. SUB 1 was also arrested and released at the scene for resisting or delaying an officer due to his resistance to cooperate when officers initially made contact. SUB 1 was cited and released on his signed promise to appear, and SUB 2 was transported to Martinez Detention Facility. **H24-00364**

**Warrant Arrest:** On April 21, 2024, at 3:25 AM an officer observed an RV parked at Home Depot. The RV was a white 2000 Thor Motor Coach Daybreak. A records check on the RV determined the registered owner, 55 year old male of Pinole, had an outstanding warrant out of Butte County. The officer initiated an investigative stop and positively identified the subject as the wanted person. The subject was placed under arrest, cited, and released at the scene. **H24-00365**
