**Miscellaneous Information:** On April 25, 2024, at 7:30 PM an Officer was dispatched to a phone detail. The Reporting Party (RP), 45 year old male, advised his son was picked up from school by the mother of his child, 46 year old female subject (SUB). There is currently no custody order in place. RP attempted to call SUB to find out where their son was, but SUB was uncooperative. Officers were eventually able to contact SUB who stated their child was with her and he was safe. **H24-00379**

**Driving Under the Influence (DUI):** On April 26, 2024, at 9:52 PM an Officer located a 2016 Chevrolet Suburban stopped in the middle of the lane at Sycamore/Palm. Officers noticed the engine was idling and a 46 year old male subject (SUB), of Richmond, sleeping in the driver's seat. Officers also noticed an open alcoholic beverage in the center console. Officers woke up SUB and he displayed objective signs of intoxication. The subject was given the Standard Field Sobriety Test; and the Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purpose of driving. SUB was arrested for DUI without incident. The Chevrolet was towed. SUB elected a breath test and was transported to Pinole PD. While at Pinole PD SUB refused the breath test and elected a blood draw. SUB was transported to HPD and Officer's authored a DUI Blood Warrant which was granted. Officers arrived on scene at 5:16 AM and observed that the rear door had signs of forced entry. A perimeter was established, and announcements were made into the store. A San Pablo K-9 unit was requested and responded to the scene. A K-9 search of the building's interior was conducted. No suspects were located. The victim, 30 year old male, responded to the scene. The total loss was a large dollars' worth of cigarettes and cash. The officer is conducting follow up. **H24-00385**
