**Fraud:** On May 22, 2024, at 10:14 AM, an officer was dispatched to the area of Worcester for a fraud report. The officer contacted the victim who stated she was contacted by someone she believed to be from Amazon who said there was fraud on her account. The suspect convinced her to withdraw a large amount of cash from her bank account and transfer it another bank account via a Bitcoin ATM. **H24-00441**

**Vandalism:** On May 22, 2024, at 11:03 AM officers were dispatched to Bank of America for a male who had just punched and broke the ATM. The subject was located in front of Dragon Terrace and identified as a 52 year old male out of Rodeo. The subject was identified as the responsible party by a Bank employee. The subject was arrested for felony vandalism and transported to Martinez Detention Facility. **H24-00442**

**Theft via Access Card:** On May 22, 2024, at 5:02 PM, an officer was dispatched to a phone detail for a lost wallet from the high school. The victim believes that she either lost her wallet or had it stolen from the high school. She realized it was missing when she got a notification from her credit card company of a transaction for a play station account. **H24-00443**

**Miscellaneous:** On May 22, 2024, at 9:27 PM HPD was dispatched to the 400 block of Violet Road to respond with Rodeo-Hercules Fire District for a possible overdose. Dispatch advised the subject was conscious, alert, but not breathing normally. Officers arrived and contacted the 22 year old male. He stated he took oxycontin two hours prior and now doesn't feel well. AMR arrived on scene and the subject declined to be transported to the hospital and signed an AMA. **Pos Stolen Mail/ Identity Theft/ False Impersonation/ Pos. Controlled Substance:**

On May 23, 2024, at 4:12 AM HPD Officers were notified via FLOCK of a 2003 Ford Focus entering city limits. The Ford was associated with a prior mail theft in Hercules. Officers located the Ford on Village Pkwy/Hercules Ave and conducted a traffic stop for a vehicle code violation. The driver initially identified himself verbally as a 29 year old male subject (SUB 1) out of New Jersey. Dispatch was unable to locate a photo of the driver with that name. The front passenger was identified as a 34 year old female subject (SUB 2), out of Benicia. In plain view Officers located a large amount of mail on the passenger floorboard that was associated with a Hercules address. Both the driver and passenger were detained for further investigation. A wallet was located in SUB 1's pocket which contained a California Driver License and bank cards belonging to different subjects, as well as fraudulent Military ID cards. Suspected fentanyl was located in SUB 2's pocket. Both parties were arrested without incident and transported to the Martinez Detention Facility (MDF) and the Ford was towed. While at MDF SUB 1's true identity was determined, 38 year old male of San Francisco. A records check showed SUB 1 was on searchable probation out of Napa County and on Federal probation. SUB 1 also had two outstanding no bail warrants out of Napa

County and one outstanding no bail warrant out of the U.S. Marshals Office. SUB 2 was booked into MDF without incident. SUB 1 was medically rejected and transported to the Contra Costa County Regional Medical Center to be medically cleared. After getting medically cleared, SUB 1 was transported and booked into MDF without incident. **H24-00445**
