Lost Property: On May 30, 2024, at approximately 7:37 PM, Officers were dispatched to a report of a lost wallet. The adult female reporting party stated that on May 20, 2024 she was pumping gas and believes she dropped her wallet. Her CA DL and credit cards were in the wallet. **Case H24-00467**

Towed Vehicle: On May 30, 2024, at approximately 8:26 PM, an Officer conducted a traffic stop on a Black Ford. The 37 year old male driver, of Hercules, was found to have no driver's license issued. The subject was cited and released for driving without a license, and his Ford was towed. **Case 24-00468**

Attempted Residential Burglary: On May 30, 2024, at approximately 8:44 PM, Officers were dispatched to the 100 block of Raleigh Ct for a report of a residential burglary. Officers contacted the victims, who stated when they arrived home, they observed two rocks appeared to have been thrown through their kitchen window. The window was slightly ajar, but it did not appear any entry had been made. The suspect(s) was possibly scared off by their alarm system. There is no apparent loss, at this time, other than window cost. **Case H24-00469**

Warrant Arrest XS/Possession of a Controlled Substances/ False ID to Peace Officer/Possession Burglary Tools: On May 30, 2024, at approximately 9:50 PM, an Officer conducted a traffic stop on a Black VW Routan. The Officer contacted the 40 year old male driver, of SF, and the 39 year old male passenger of SF. The driver initially lied about his name and date of birth; however, a check of the VW's registration showed the driver as the registered owner. The driver had multiple, no bail, outstanding warrants for his arrest. The warrants ranged from Contra Costa County, San Bruno and Pacifica with various charges including narcotics, vehicle theft and burglary tools. A Cal-Photo confirmed the driver's identity and thwarted the false identification ruse. A search of the driver's person revealed suspected methamphetamine and shaved keys. The driver was arrested and booked at the Martinez Detention Facility on his on-view charges and outstanding warrants. The passenger was released on scene with the VW. **Case H24-00470 / H24-00471 / H24-00472 / H24-00473**

Towed Vehicle: On May 30, 2024, at approximately 10:59 PM, an Officer conducted a traffic stop on an Audi A5. The Officer contacted a 27 year old

male driver, of Hercules. The Audi had a false registration tab on the rear license plate and the Audi's registration was expired. **Case H24-00474**

Warrant Arrest: On May 31, 2024, at approximately 1:01 AM, an Officer conducted a traffic stop on a gray Toyota Corolla. The Officer contacted the occupants and learned the 27 year old female front passenger, of Richmond, had an outstanding, no cite, warrant for her arrest. The warrant was issued by Solano County SO and was for Driving Under the charges. The subject was arrested and was transported to the Martinez Detention Facility.

Towed Vehicle On May 31, 2024 at 10:29 AM an officer checked on an apparent abandoned vehicle in the 800 block of Willow Avenue. The vehicle was a 2011 Gray Nissan Maxima and had registration expired for over six months and a day. The vehicle was towed. **H24-00476**

Criminal threats/Brandishing: On May 31, 2024 at 10:57 AM officers responded to the 3100 block of N Front Street. The CHP dispatch advised they took a call from a female who said her husband was trying to steal her dog. The 47 year old female victim also advised the male pulled out a handgun and threatened her with it. The suspect was identified as a 36 year old male, from Vallejo. Prior to the officers arrival the male fled in a red Ford Edge and was possibly heading for Vallejo. Officers received information that the subject was parked in front of his mother's house in the 400 block of La Jolla Street in Vallejo. Officers responded to Vallejo and contacted the subject, and a 43 year old female companion. They were safely detained and a silver imitation pistol, similar to a Glock pistol, was located on the front passenger floorboard where the male subject was seated. The male was arrested and transported to HPD then to the Martinez Detention Facility. Th female was released on scene. **H24-00477**

Residential Burglary: On May 31, 2024 at 12:39 PM officers responded to the 100 block of Decatur Court for a residential burglary. The 25 year old male reporting party advised an unknown subject(s) forced entry into his home and attempted to get into his room where he was. As soon as the unknown suspect(s) saw the reporting party, he (they) fled out of the home **H24-00478**

Medical Assist: On May 31, 2024, at approximately 7:41 PM, Officers were dispatched to the 100 block of S Wildwood for a report of a female screaming for help and gasping for air with a voice yelling in the background. The reporting party stated she was inside the above address. The front door was locked, and she could not get up to open the door. Officers arrived and attempted to contact the reporting party, with no response. Movement was heard from in the residence and forced entry was made. Officers cleared the residence and did not locate anyone inside. Dispatch located a possible address in the 2200 block of John Muir Pkwy. Officers arrived and contacted the reporting party through the door. The reporting party could not get to the door and was suffering a medical

emergency. Officers forced entry again and Fire arrived to render aid. The 75 year old female was transported to a local hospital. Management at the apartment building was contacted and responded for the front door. The homeowners of address on S Wildwood were contacted and public works responded to secure the door. **Case H24-00479**

Possession Controlled Substance/Probation Violation: On May 31, 2024, at approximately 11:44 PM, An Officer conducted a pedestrian stop on two individuals in the area of Refugio Valley Road and Pheasant Dr. A 36 year old male, of San Pablo. and a 57 year old male, of Pinole, were contacted. The younger male was found to be on searchable Contra Costa County Probation. Located, on the subject's person, was a small amount of suspected Methamphetamine. The younger male was arrested, cited, and released on scene. **Case H24-00480**

Violation of a Domestic Violence Restraining Order, Harassing Phone Calls: On June 1st, 2024 at 8:39 PM and officer was contacted by a 47 year old female who advised her 46 year old husband was calling her and harassing her repeatedly in violation of a served domestic violence restraining order. The victim was able to provide screen shots of the repeated phone calls as evidence. A case was taken to be forwarded to the district attorney for prosecution. **H24-00481**

Possession of a Controlled Substance: June 1, 2024, at approximately 7:56 PM, an Officer conducted a vehicle check on a 1999 Toyota Camry parked at Safeway. A 49 year old female, and a 37 year old female, both from Oregon, were contacted. A probable cause search was conducted on the Toyota. Both subjects were found to be in possession of suspected narcotics. Both were arrested, cited, and released on scene. **Case H24-00482**

Warrant Arrest: On June 2, 2024, at approximately 1:56 AM, an Officer conducted a traffic stop on a 2001 Mercedes SUV. A 24 year old male, of Rodeo, was contacted in the driver's seat. The subject's driver's license was suspended/revoked. He also was found to have a felony warrant for robbery issued by Palo Alto. The warrant was citable. The subject was arrested, cited, and released on scene. The Mercedes was towed. **Case H24-00483**

Vandalism: On June 2, 2024, at 8:03pm, an officer responded to the 200 block of Apollo for a report of vandalism. The reporting party said he arrived home this evening to find his Ring camera on the ground and his door was damaged. **H24-00484.**

Towed Vehicle: On June 3, 2024, at 8:41 am, an officer checked on a vehicle parked in the 100 block of Pepperwood. The vehicle, a 2006 Silver Pontiac Vibe with Arizona Plates, was found to have expired in 2002. The Vibe was towed for the expired registration. **H24-00485**

Embezzlement: On June 3, 2024, at 11:42 am, an officer was dispatched to the Lobby of the Hercules Police Department for an embezzlement case. The reporting party stated he was part of a board of directors for an umpire association. He stated the adult female treasurer of the association recently resigned. It appears she embezzled a large sum of money from the organization. A case was taken, and the officer is conducting follow up. **H24-00486**

Lost Property: On June 3, 2024, at 2:26 pm, a resident from the 100 block of Dunham Ct. came into the Hercules Police Department to report a handgun missing from his home. The reporting party stated the item was last seen was in February. The firearm was entered into the Automated Firearms System. **H24-00487**

Criminal Threats / Resisting: On June 3, 2024, at 6:55pm, officers responded to the Paradise apartment complex for a report of criminal threats. The threats reportedly involved reckless driving in the complex. The victim stated the 30 year old male suspect, told she and her daughter, he had a rifle and was going to "put them in caskets". The victim stated she does not know the suspect and was fearful for both her and her daughter's life. The victim desired prosecution. Officers contacted the suspect, in the 100 block of Paradise Dr. He was intoxicated and uncooperative and refused to comply with instructions for detainment. Upon physical contact the subject attempted to pull away from officers, and passively resisted handcuffing. He was put on the ground for detainment and subsequent arrest. Th subject was not injured and was transported to the Martinez Detention Facility without further incident. **H24-00488**
