**Shoplifting:** On June 6, 2024 at 1:23 PM officers responded to Luckys at 1590 Sycamore Avenue for a report of a theft. The suspect vehicle was described as a silver Lexus RX300 (license plate reported). A female was seen loading stolen items into the vehicle. Officers located the vehicle and stopped it at the Safeway Gas Station. The 45 year old female driver, of Oakland, and the 31 year old male passenger, of Brentwood, were detained. Both subjects were identified by a Lucky's employee as the responsible parties. Multiple stolen items were located within the vehicle. The male was arrested, for Shoplifting, cited, and released on scene. The female was arrested and cited for the Shoplifting charge. She was transported to HPD for a separate charge (see case H23-00498 below). **H24-00497** 

**Driving Under the Influence (DUI):** During the above incident the female driver displayed objective signs of intoxication. The Standard Field Sobriety Test was conducted. The Preliminary Alcohol Screening test indicated the subject was over the presumptive limit for the purposes of driving. The subject was arrested and transported to HPD for a blood alcohol chemical test. The subject was later cited and released for the theft and DUI. **H24-00498** 

**Vandalism (Graffiti)** On June 6, 2024 at 4:09 PM officers responded to the walking path between Forest Run and Sycamore Avenue that runs parallel to the train tracks. The reporting party advised there was someone spray painting the fence belonging to the Forest Run Homeowner's Association. Officers located a 25 year old male, from Vallejo, fleeing the area with a bucket full of spray paint. Officers were able to detain and arrest the subject. The estimated damage caused to the fence and Railroad property was estimated to be over \$2,000. The subject was transported to the Martinez Detention Facility. **H24-00499** 

**Towed Vehicle:** On June 6, 2024, at approximately 8:20 PM, an Officer conducted a traffic stop on a 2017 Infiniti QX70. The Infiniti's registration expired in July of 2023; however, a 2024 year registration tab was on the rear license plate. The Officer contacted the 28 year old male driver, of Richmond, and the 31 year old passenger, of Antioch. The Infiniti was subsequently towed for the registration violation. The occupants were released. **Case 24-00500** 

**Possession of Methamphetamine:** On June 07,2024 at 1:03 PM an officer conducted a traffic stop on a Mercedes on I-80 westbound on-ramp and John Muir Pkwy. One of the occupants of the vehicle was identified as a 37 year old male, from San Mateo. The subject was in possession of suspected methamphetamine and drug paraphernalia. The subject was arrested, cited and released. **H24-00501** 

<u>Mental Health Evaluation</u>: On June 7, 2024, at approximately 9:10 PM, an Officer was flagged down at the 76 Gas Station for a possible destressed subject. Officers contacted a 22 year old female, of Rodeo. She was deemed to be a danger to herself after attempting to

jump out of her friend's moving vehicle. The subject was transported, by ambulance, to the Contra Costa Regional Medical Center. **Case h24-00502** 

<u>Miscellaneous Investigation</u>: On June 7, 2024, at approximately 10:04 PM, an Officer was flagged down at Safeway for an unknown issue. The Officers contacted the two adult parents of a male juvenile. The parents stated that their son was bullied at Refugio Valley Park by a group of kids. Their son was reportedly shot with a gel gun. A case taken for documentation. **Case H24-00503** 

**Evading/Resisting Arrest:** On June 8, 2024, at approximately 1:14 AM, an Officer conducted a traffic stop on an Acura MDX, with no plates, at Shell Gas Station. Officers contacted the driver, later identified as a 40 year old male, of San Pablo. The subject was the sole occupant. The driver refused to roll his windows down or identify himself. An Officer utilized a tire deflation device and placed it under the Acura's right rear tire. The subject became more uncooperative and fled the traffic stop. The deflation device successfully deployed on the right rear tire. The Acura fled from Shell onto westbound I-80. Officers trailed from a distance as dispatch contacted CHP. No pursuit was initiated. Officers observed as the Acura exited onto Pinole Valley Rd at approximately 35 mph. The Acura turned into the Sprouts parking lot where Officers conducted a high risk stop. The subject was taken into custody without further incident. The Acura was clear of any wants. The subject was taken to the Martinez Detention Facility, and the Acura was towed. **Case H24-00504** 

**Recovered Stolen Vehicle/Mail Theft/Resisting Arrest:** On June 8, 2024, at approximately 3:55 AM, Officers were dispatched to a possible mail theft in progress, in the area of the 100 block of Cardinal Way, with two subjects involved. Officers circulated the area. In the 200 block of Starling Way, an Officer observed a male adult, wearing all black, reaching inside of a Blue Mazda. Upon noticing the Officer the male ran, on foot, down Starling Way. An Officer located the male hiding in a bush in front of a residence in the 100 block of Starling Way. The 34 year old male, of Antioch, was detained. The vehicle the subject was seen leaning into contained a large bag filled with mail. Officers learned this was not the subject's vehicle, but he had gained access to the vehicle. It was later determined the owner keeps the vehicle unlocked and it is not used/nonoperational. With assistance from Pinole PD, Officers continued to circulate looking for the second subject. An Officer located a Honda Accord, parked in the 100 block of Cardinal Way. The license plate did not match the vehicle. A check of the Honda's VIN revealed it was an outstanding stolen vehicle reported to Antioch PD on June 3, 2024. Officers were unable to locate the second subject. The known subject was arrested and transported to the Martinez Detention Facility for mail theft and resisting/delaying a peace officer. <u>Stolen Vehicle:</u> On June 08,2024 at 8:08 AM an officer responded to the 2000 block of Pheasant Drive for a black Lexus ES 350 which had been stolen from the driveway of the reporting party's residence. The 31 year old female victim reported the Lexus was last seen the night before at 10:30 PM. The victim also stated she had left her Gucci purse in her silver Cadillac STS which contained the keys to the Lexus. The suspect gained access to the Cadillac, stole the purse, and located the keys to the Lexus. **H24-0506** 

**Stolen Vehicle Recovery:** On June 08,2024 officers received a FLOCK notification of a black Dodge Charger with a stolen plate attached to the rear of the vehicle. It was traveling eastbound on Refugio Valley Road towards Hercules High School. Officers began to check the area including the high school due to it hosting graduation. At 11:20 AM an officer located the black Charger on the south side of the school. Officers conducted a record check on the VIN and dispatch advised it was stolen out of San Francisco. No suspects were contacted at

this time and the vehicle was recovered and towed. The stolen plate was also recovered and removed from SVS. **H24-00507/ H24-00508** 

<u>Mental Health</u> On June 08, 2024 at 4:51 PM officers responded to the 1500 block of Chelsea for a 28 year old male hitting himself and passing out. Officers arrived and contacted the subject, and he was safely detained. The subject was determined to be a danger to himself and was placed on a mental health hold and transported, by ambulance, to the Contra Costa Regional Medical Center. **H24-0509** 

<u>Vehicle Vs Bicyclist Collision</u> On June 08, 2024 at 5:57 PM officers responded to Refugio Valley Road and Redwood Road for a collision involving a vehicle and a bicyclist. The vehicle was a gray Toyota RAV4, travelling south on Redwood Street entering the roundabout. The bicyclist was traveling westbound on Refugio Valley Road when entering the roundabout. The bicyclist broadsided the Toyota causing minor damage to the vehicle. The bicyclist injured his shoulder and collarbone. The driver was identified as 53 year old male, from Pinole. The 45 year old male bicyclist, from Hercules, was transported to a hospital by AMR. **H24-0510** 

<u>**Hit and Run:**</u> On June 9, 2024, at 11:43 am, a resident came into the Lobby of the Police Department to report a hit and run that occurred this morning at The Home Depot. The resident stated an unknown suspect vehicle hit his parked vehicle while he was inside The Home Depot. <u>**H24-00511**</u>
