**Domestic Violence** On June 13, 2024, at 3:33 PM, officers responded to the 2100 block of Forest Run. The 32 year old female reporting party advised her 31 year old boyfriend, from San Bruno, was causing a disturbance and refusing to leave. The female said she found the male in the restroom and believed he was using drugs. A physical altercation ensued, and the female was determined to be the primary aggressor. The male's sweatshirt was torn, and he had a minor bump to the back of his head. The female was arrested and transported to the Martinez Detention Facility. **H24-00524** 

**Possession of a Loaded Firearm:** On June 13, 2024, at approximately 8:35 PM, an Officer conducted a traffic stop on a 2004 Toyota Solara at Valley Bible. The 31 year old male driver, of Pittsburg, was the sole occupant. While speaking with the driver, a crossbody style bag was observed on the floorboard next to his feet. The Officer asked the subject if he would open the bag. The subject opened the crossbody bag partially revealing a firearm. The subject was detained without incident. A loaded pistol was recovered from the bag. The pistol was registered to the subject. The subject was arrested and later cited and released at the Hercules Police Department. **Case H24-00525** 

**Stolen Vehicle Recovery:** On June 14, 2024, 10:16 am, HPD units received a Flock ALPR hit for a stolen gray 2024 Ford Edge, traveling southbound on Willow Ave. at Sycamore Ave. The vehicle was reported stolen to Oakland PD on June 06, 2024. An Officer located the vehicle parked in front of Big Lots. The 69 year old male driver, of Rodeo, was detained without incident. The subject, and his adult son, rent vehicles on Turo, and the Ford was an overdue rental. The subject informed Officers shortly after the vehicle was reported stolen, he located the vehicle. He reported the recovery to Turo but not to law enforcement. As a result, the vehicle remained in the Stolen Vehicle System (SVS). The subject's son, and Registered Owner of the vehicle, later responded to the scene to take possession of the vehicle. The vehicle was then removed from SVS. The subject was released. **H24-00526** 

**Towed Vehicle:** On June 14, 2024, at 11:20 am, an Officer was dispatched to the 1000 block of Pebble Bay for the report of an abandoned gray 1991 Toyota Landcruiser. An Officer located the Toyota and conducted a record check on the vehicle for the registered owner information and registration status. The records check revealed the vehicle's registration has expired since 2021. As a result, the vehicle was towed for the registration violation. **H24-00527** 

**Stolen Plate:** On June 14, 2024, at 4:09 pm, an Officer was dispatched to the 100 block of Decatur Ct. for the report of a stolen license plate. Sometime between June 12, 2024, at 4:00 pm, and time of call, an unknown suspect stole the front license plate off their white 2003 Honda Civic. The victim stated he normally parks his Honda at the Del Norte BART station in El Cerrito and is unsure if the license plate was stolen from his Honda while parked at the

BART station, or while parked at his home in Hercules. The license plate was entered into SVS. <u>H24-00528</u>

**Towed Vehicle**: On June 14, 2024, an Officer conducted a vehicle check on a 2002 GMC Sierra in the Home Depot parking lot. The GMC had a false registration tab on the rear license plate. The 24 year old male driver, of Woodland, was contacted. He stated he was borrowing the truck. The ignition of the GMC was destroyed, and a screwdriver was used to start the vehicle. The listed registered owner stated they had sold the GMC a while ago and do not have contact information for the new owner. The GMC was towed for the registration violation. **Case H24-00529** 

**Driving Under the Influence (DUI)/Criminal Threats/Resisting Arrest:** On June 14, 2024, at approximately 8:09 PM, while working traffic enforcement at the intersection of John Muir Pkwy at Alfred Nobel, an Officer observed a 2016 Nissan Altima fail to stop at the posted stop sign at the intersection. A traffic stop was affected on the Altima. The 59 year old male driver, of Hercules, was contacted. The subject displayed objective signs and symptoms of intoxication. The subject was administered the Standard Field Sobriety Test. The Preliminary Alcohol Screening device indicated he was over the presumptive limit for the purposes of driving. The subject was placed under arrest and the vehicle was towed from the scene. The subject refused to take one of the required blood alcohol tests (breath or blood) A blood DUI warrant was authored, approved, and served on the subject. The subject became resistant during the blood draw, having to be held down for only a partial blood draw. The subject also made verbal threats of harm towards Officers. The subject then stated he was having a medical emergency. AMR arrived and transported him to the Contra Costa Regional Medical Center. The subject was eventually cleared and booked at the Martinez Detention Facility. **Case H24-00530** 

<u>Mental Health Evaluation</u>: On June 15, 2024, at approximately 12:04 AM, Officers contacted a 66 year old female, of Oakland, who was in a stalled vehicle on Sycamore Ave/Willow Ave. After contacting the subject, the officer determined she was a danger to herself. The subject was transported to the Contra Costa Regional Medical Center by AMR. **Case H24-00531** 

**Possession of a Loaded Unregistered Firearm:** On June 15, 2024, at approximately 1:03 AM, an Officer conducted a vehicle check on a 2022 Toyota Highlander that was parked at the dead end of Lavender PI. The Officer contacted a 23 year old male, of Richmond, and a 22 year old female, of Hercules. The subjects were smoking Marijuana inside the enclosed vehicle. A probable cause search was conducted of the Toyota. Located, under the driver's seat, where the male was seated, was a fully loaded pistol. A record check, of the pistol, revealed "no record found". The Toyota was released to the female on scene. The male was arrested and transported to the Martinez Detention Facility. **Case H24-00532** 

<u>Missing Person Locate</u>: On June 15, 2024, at approximately 5:01 AM, an Officer contacted a 33 year old male, of Washington. The subject was listed in the Missing and Unidentified Persons System, on June 6, -2024, by East Wenatchee PD. The subject was evaluated and released. **Case 24-00533** 

**Stolen Vehicle:** On June 15,2024 at 5:00 PM, an officer responded to the 1100 block of Forest Run regarding a white Acura TLX Type S, stolen from the Forest Run parking lot. The 40 year old male victim advised he parked his Acura in his parking stall on June 13, 2024, at 2:00 PM. When he went to his vehicle today, he noticed it was gone. **H24-00534** 

<u>Stolen Vehicle:</u> On June 16,2024, at 9:02 AM, an officer responded to the 200 block of Falcon Way for a report of a stolen dark gray Dodge Charger (GNRS). The Charger was taken from the residence at 2:44 AM this morning. Surveillance video shows three unknown suspects pushing the vehicle out of the driveway. **H24-00536** 

**Strong Arm Robbery:** On June 16, 2024, at 2:38 PM, officers responded to Home Depot at 1625 Sycamore Avenue for a theft that occurred, and the suspects had left in an older red truck with a primer-colored tailgate. The suspect was described as an adult male, wearing a white and blue sweatshirt. The take was a red tool kit and hand tools. The suspect had a physical altercation with a Home Depot Loss Prevention Officer and the suspect fled with the merchandise. **H24-00537** 

Hit and Run Non-Injury DUI: On June 16, 2024, at 7:55 pm, Officers were dispatched to the 100 block of Tanager Way. The reporting party stated a white pickup truck struck multiple parked vehicles in the area and fled the scene. While enroute, dispatch advised they had several more callers reporting the suspect vehicle was heading down Falcon towards Refugio Valley Road, then towards Hannah Ranch. Callers advised the suspect vehicle was missing a wheel. Units closed in on the area, attempting to follow the truck's path, and located another apparent victim vehicle in the 400 block of Falcon. One of the victims provided an officer with a front plate, reportedly from the suspect truck. The plate detached during the collision. A record check indicated the vehicle was registered to a residence in the 100 block of Fremont Ct. Officers responded to the 100 block of Fremont Ct. They located a white truck with major damage, and apparent airbag deployment, in a driveway. The 31 year old male driver, was detained without incident. The driver showed symptoms of intoxication. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. The subject was cleared by AMR on scene and arrested. He transported back to HPD for a consensual blood draw. Officers responded to all collision areas to take statements and documented the damage to 6 different vehicles along his path. All the vehicles hit were parked and there were no injuries reported. The subject was later cite released to his parents for DUI and hit and run. H24-00338 / H24-00339.

**Auto Burglary:** On June 17, 2024, at 12:20 am, Officers were dispatched to a carjacking in progress in the 1000 block of Regatta Point. While in route, dispatch updated units that it was an attempt only and the subject was described as a male adult, wearing a gray and white hoodie, black pants and white shoes. He was last seen heading, on foot, towards Victoria Crescent West. Officers established a perimeter at the major intersections to block off the area, deployed a drone and drove the bay trail. No subjects or possible associated vehicles were located. After interviewing the victim and obtaining surveillance footage, it was confirmed the incident was not an attempted carjacking or vehicle theft. The incident was determined to be an auto burglary. The loss from the vehicle was cash and sunglasses. **H24-00340**.
