Welfare Check: On June 19, 2024, at 12:15 pm, Officers were dispatched to the 100 block of Wadi Run. The reporting party (RP) said his 63 year old mother was "high off fentanyl" and he was asked to contact the Police. Officers contacted RP who stated that his mother and 27 year old brother had gotten into an argument just prior to the time of call. The brother had threatened to overdose on Fentanyl in his room. The RP told the Officers his mother and brother were currently inside the brother's bedroom. Officers attempted to call the two subjects out of the bedroom but received no answer. The bedroom door was locked. Officers again attempted to get the two subjects to come out of the bedroom by knocking loudly on the door and calling out to them. There was no answer, and Officers did not hear any movement in the bedroom. Officers were concerned that the two subjects were suffering from a possible drug overdose and forced entry into the room. Neither subject was present. Officers checked the home and the garage. The subjects were not located, and the mother's vehicle was gone. The reporting party reached his mother by phone. She told him everything was fine, and they were visiting another family member at a hospital. The case was taken for documentation purposes only. H24-00547

**Shoplifting:** On June 19, 2024, at 1:22 pm, Officers were dispatched to Big Lots for the report of a theft that just occurred. The suspect was described as a male adult, wearing a red hat and red shirt. The reported loss was clothing items. An area check for the suspect was conducted but he was not located. **H24-00548** 

**Stolen Plate:** On June 19, 2024, at 4:00 pm, an Officer handled a lobby detail for a reported stolen license plate. The 25 year old female victim stated when she got off from work today, she parked her car. Later she returned to her vehicle and noticed the rear license plate to her 2016 Hyundai was missing. The victim lives in San Francisco but works in Hercules. She stated she last saw the license plate attached to her vehicle yesterday at approximately 5:00 pm. **H24-00549** 

**Domestic Violence/Assault with Deadly Weapon:** On June 19, 2024 at 11:15 PM Officers responded to the area of Southwind and Sunset Dr for a reported male with stab wounds. Dispatch advised the adult male victim was reportedly

stabbed by his 40 year old girlfriend. The suspect had fled the scene. Officers located the victim standing next to his vehicle. He had two small stab wounds to his back. The investigation determined the crime occurred approximately 30 minutes prior to the call, in the parking lot across from an Elementary school. The victim said he got into an argument with his girlfriend, and she stabbed him in the back. The victim sustained two cuts, approximately one inch long, to his right shoulder blade. The suspect vehicle was described as a Chrysler van with Colorado license plates. A FLOCK search showed the van last hit in Vallejo 20 minutes prior to the call. A Be On the Look Out was sent out to Vallejo PD. The victim was transported to a local hospital. An Emergency Protective Order was granted. Approximately one hour later, HPD received a call from an ER nurse at a hospital in Vallejo. The alleged suspect came in with her two juvenile sons and claimed they were assaulted, in Hercules. HPD Investigations were called out to respond to Vallejo the hospital. The female subject was served the EPO. Due to there being no other family members to take custody of the juveniles and the circumstances of this case, the female was not arrested. The case will be forwarded to the DA's Office. H204-00550
