No refunds for any payment option after March 27, 2025. ☐ The City of Hercules **reserves the right to modify** any conditions of this agreement upon 30 days' written notification to the parents or guardians. ☐ The Parent/Guardian agrees that he/she has received or reviewed a copy of the PARENT HANDBOOK and agrees to all the Program's operating policies and procedures as described therein. Parent/Guardian understands he/she must go online to the City of Hercules website to the Recreation webpage and review and print out the RAP Parent Handbook. You may also view a copy of the RAP Parent Handbook in each of the classrooms. ☐ **Termination Conditions**: This agreement may be terminated by the Kaleidoscope Kidz RAP with a one-week notice for the following reasons: A. Parent/Guardian has not cooperated with the Kaleidoscope Kidz RAP regarding the child's discipline needs. B. If full payment is not made by the 6<sup>th</sup>, your child will not be allowed to continue in the program until tuition is paid in full. C. Late payments: Received on the 6<sup>th</sup> 1<sup>st</sup> late payment you will be charged \$36.00 and 2<sup>nd</sup> late payment \$41.00. D. NSF fee: Insufficient funds. This is when the status of a checking or credit card account does not have enough money to cover the transaction. A decline in credit card transaction is your responsibility. We encourage you to update your credit card by the 1st of the month. All returned checks/credit card must be cleared with cash, money order or cashier check. Credit card policy does not allow returned checks to be cleared with a credit card. If a household has 2 NSFs occur in the span of 1 year, all future payments must be made in cash, money order, or debit card. E.
