Theft: On June 20, 2024 at 3:27 PM an officer responded to Starbucks at 842 Willow Avenue. The manager stated, approximately 30 minutes prior to calling police, two female adults entered the coffee shop. The subjects distracted the employees and began to grab as much merchandise as possible, which included tumblers. The loss was estimated to be valued at \$180. The two female suspects fled in a white 2012 BMW. **H24-00551**

Warrant Arrest (VSET): On June 20, 2024 officers working VSET in Antioch conducted a traffic stop on a vehicle and contacted a 33 year old male. The subject had two felony warrants from Richmond and Antioch, and both were confirmed. The subject was transported to the Martinez Detention Facility. **H24-00552**

Stolen Vehicle: On June 21, 2024 at 7:19 AM an officer responded to the 2500 block of Bayfront Blvd regarding a stolen black Toyota Camry. The vehicle is registered to 42 year old male, from Hercules. The registered owner runs a car rental service, and the Camry was overdue for 11 days. The vehicle was later recovered by the LAPD Harbor Division. The vehicle has been removed from SVS by LAPD. **H24-00553**

Warrant Arrest: On June 21, 2024 at 7:31 AM an officer contacted a 31 year old male. The subject had a confirmed outstanding warrant for burglary. He was arrested and transported to the Martinez Detention Facility. **H24-00554**

Evading/Outside Assist: On June 21, 2024 at 7:49 AM officers received a FLOCK notification of a silver Dodge Charger with a stolen plate attached to the rear. The Charger hit throughout the City and an officer located it traveling westbound Hercules Avenue and Zeus. The officer attempted to conduct a traffic stop on the Dodge and it failed to yield. Officers did not engage in a pursuit, and the vehicle was last seen traveling south on San Pablo Avenue towards Pinole. Once the vehicle entered Pinole it was involved in a collision with another vehicle. Pinole PD responded and investigated the collision. **H24-00555**

Towed Vehicle: On June 21, 2024 at 10:45 AM our Parking Enforcement Officer located a Carry Craft Trailer parked at Tsushima Street and Riverview Terrace. The trailer's registration had been expired for over six months and a day. The trailer had also been in the same location for over 72 hours. The trailer was towed. **H24-0556**

Strongarm Robbery/ Conspiracy: On June 21, 2024 at 8:39PM Officers were dispatched to a robbery that occurred at Home Depot. Dispatch advised three suspects stole spray paint and one of the suspects punched an employee's in the face while fleeing. One suspect was described as wearing a bright yellow jacket. The suspects were seen getting into a gray SUV. Officers arrived on scene and were directed by the employee to an occupied gray Volkswagen SUV and detained a 23 year old male subject wearing a yellow jacket. After reviewing the surveillance video, it was determined the detained subject was not the suspect.

The surveillance footage showed the suspects were confronted by an unknown good Samaritan who attempted to stop the theft by grabbing one of suspects. The employee stood by and attempted to retrieve the items and was punched in the nose by one of the suspects. The suspects fled in an unknown make/model gray SUV. Officers conducted an area check and were unable to locate the suspect vehicle. The loss was approximately \$800. **H24-00557**

Warrant Arrest: On June 22, 2024 at 1:56 AM an Officer conducted a traffic stop on a Honda Civic. The 23 year old female driver was determined to have a non-citeable warrant for theft. The subject was arrested and booked at the Martinez Detention Facility without incident. **H24-55008**

Commercial Burglary: On June 22,2024 at 9:49 AM an officer responded to West Coast Drilling at 1350 Willow Avenue. The reporting party said an unknown suspect(s) cut the fence connecting their business and the truck yard next door. The subject(s) hooked up a storage container to a vehicle and pulled it from the West Coast Drilling yard to the truck yard. The unknown suspect(s) also stole a Lincoln welding machine. **H24-00559**

Evading: On June 22,2024 at 11:46 AM an officer was traveling westbound in the 1200 block of Willow Avenue when a dark gray Hyundai Sonata was seen driving recklessly. at a high rate of speed. failing to stop at stop signs. The officer attempted to conduct a traffic stop but the vehicle failed to yield and continued driving at a high rate of speed eventually getting onto eastbound HWY 4 from Sycamore Avenue. A Be On the Look Out was put out for CHP. **H24-00560**

Outside Assist: On June 22, 2024, at 7:30pm, a Pinole PD officer attempted a pedestrian stop on three adult male subjects under the bridge between Pinole and Hercules. It was later determined the subjects were tampering with phone line wires. All three subjects immediately fled the area heading SB on the train tracks. Hercules officers were able to assist in establishing a perimeter which led to the arrest of one of the subjects, a 49 year old male. A second subject, a 30 year old male, was located hiding nearby in the Pinole Creek. With the assistance of CCSO helicopter the subject was taken into custody without incident. A CCSO K9 responded to the scene but the third subject was not located. **INC#0137**

Towed Vehicle: On June 23, 2024, at 10:34 am, an Officer conducted a vehicle check on a tan 2007 Hyundai Sonata that was parked in the Chase bank parking lot. Attached to the front and rear bumpers of the Sonata was a license plate number printed on regular paper and laminated. The Officer conducted a record check of the license plate number and it matched the vehicle. However, the license plate number was printed in the same format as a temporary license plate, and it listed the vehicle's registration as valid until August 2024. The record check indicated the vehicle's registration had expired since 2012, with DMV fees last paid in 2019. As a result, the Officer towed the vehicle for the registration violation. During an inventory search of the vehicle, the Hyundai's actual license plates were located inside the vehicle's trunk with expired tabs. **H24-00561**
