Shoplifting: On June 25, 2024, at 6:44 am, Officers were dispatched to Home Depot for the report of a theft that just occurred. A suspect described as a male adult wearing a black shirt, a hat, and brown pants, walked out of the store and stole a plastic bin containing suspected power tools. The suspect got into a black BMW sedan and fled the scene. He was last seen driving towards Round Table and was gone upon police arrival. **(H24-00566)**

Domestic Violence: On June 25, 2024, at 10:54 am, Officers were dispatched to Arete Ct. for a report of domestic violence. Officers were advised a 26 year old male subject, of San Francisco, was at the residence to pick-up his 9 month old son. The subject and his son's 29 year old mother, of Hercules, got into an argument. The argument turned physical when the subject pushed the female victim into a wall and struck her in the head with a plastic bag filled with miscellaneous baby care items. The subject then left the home, with his son, before police arrival. The subject was contacted by phone and denied hitting the victim, claiming she hit him as she pushed him out of her home. There is no current child custody order in place, and the baby did not appear to be in any immediate danger. An Emergency Protective Order was granted to the victim. The subject was told to surrender his son back to his mother. The subject said he would arrange to take his son with the victim's mother. **(H24-00567)**

Towed Vehicle: On June 25, 2024, at 11:28 am, a parking enforcement officer towed a green Toyota Sienna from the Home Depot parking lot. The Toyota appeared abandoned and had been issued a 10-day parking warning. **H24-00568)**

Vehicle Tampering: On June 25, 2024, at 1:26 pm, an Officer responded to the 400 block of Olympus for the report of stolen license plates. The 42 year old female victim stated both license plates to her white 2001 Toyota 4-Runner were last seen on her vehicle on June 22, 2024. She noticed the plates were missing this morning as she was drying her vehicle after washing it. The license plate was entered into the Stolen Vehicle System. **(H24-00569)**

Mental Health Evaluation: On June 25, 2024, at 7:06pm, officers responded to the 100 block of Rosti for a Mental Health Evaluation. The reporting party stated her husband left the hospital prior to the end of his care after surgery and was home mixing his medication with alcohol. The male subject was acting irate and making threats to her. Upon evaluating the husband, he would not agree to receive medical treatment and made threats toward officers and family members. Based on the husband's statements and recent actions he was determined to be a threat to himself and others. AMR responded to the scene and transported him to the Contra Costa Regional Medical Center for a Mental Health Evaluation. **H24-00570**
