Lost Property: On July 1, 2024, at 1:31 pm, a resident came into the lobby of the Hercules Police Department to report his phone and wallet lost. The victim stated that he rode in an Uber from Pinole to his house in the 100 block of Mulberry Ct. and when he got home, he realized that he had left his phone and wallet in the Uber. A case was taken for lost property and the Credit Cards and Identification was entered into the Automated Property System. **H24-00593**

Warrant Arrest: On July 1, 2024, at 6:50pm, officers received a FLOCK notification of an Infiniti traveling up Canterbury. An officer located the unoccupied vehicle in front of a residence in the 200 block of Newbury. The officer had knowledge that the 29 year old male registered owner of the Infinity had an extraditable 10K warrant, for identity theft, out of Virginia. The officer conducted surveillance on the Infinity, from a distance. The officer observed the registered owner leave in the vehicle. A traffic stop was conducted at the intersection of Newbury and Canterbury. The subject's identity, and the warrant, were confirmed. The subject was taken into custody, without incident, and transported to the Martinez Detention Facility. **H24-00594.**

Miscellaneous. Information: On July 1, 2024, at 8:05pm, Officers conducted a welfare check on a subject laying on the sidewalk behind Safeway. The subject verbally identified himself as a 39 year old male. He appeared disoriented but was not in need of medical attention. A record check revealed the subject had a warrant for robbery out of San Francisco. After a Cal photo verification of the subject's identity, the warrant was confirmed. The subject was arrested and. transported to the Martinez Detention Facility without incident. While at the jail a fingerprint verification revealed the subject was not the correct person listed on the warrant. The subject was released with no record of arrest. **H24-00595.**

Possession of Stolen Vehicle: On July 1, 2024, at 10:49pm, an officer observed a Honda Civic with a temporary rear plate, and no front plate, backing into a spot in the Safeway parking lot. The driver quickly exited the vehicle and walked inside Safeway. A record check on the temporary plate revealed it did not belong to that vehicle and a records check, on the VIN number, revealed it was stolen out of Antioch. Officers responded to Safeway where they located the 32 year old male subject and took him into custody without incident. A custody search of the subject revealed several credit cards and a driver's license, belonging to other people. The subject was transported to the Martinez Detention Facility, and the Honda was towed. **H24-00596.**
