Stolen Vehicle Recovery: On July 3, 2023 at 12:43 pm, an officer was dispatched to the back lot of the Police Department where a tow truck was waiting. The driver towed a vehicle from private property. When the company called to report the vehicle as a private property tow it was determined the plates did not belong on the vehicle and the vehicle was stolen. The Black 2004 Toyota Avalon had a plate that did not belong on it and was found parked on private property, in the 300 block of Bristol. The vehicle was stolen in October of 2023 and the plate, found on the vehicle, was not reported as lost or stolen. When the officer gained access to the vehicle there were three more plates located in the vehicle none of which were the plates that belonged on the vehicle. All of those plates were reported as lost or stolen. The vehicle and the plates were removed from SVS. **H24-00600**

Possession of a controlled substance: On July 3, 2024 at 8:19 PM an Officer conducted a vehicle check on a Dodge Ram at Safeway. The Officer observed drug paraphernalia, in plain view, as the 37 year old male owner approached the vehicle. A 56 year old male also approached the vehicle and attempted to grab something out of the vehicle. Both subjects were detained without incident. A probable cause search of the vehicle was conducted and suspected methamphetamine was located. During the investigation, neither subject took ownership of the drug paraphernalia or methamphetamine. As a result, both subjects were arrested. They both were cited and released without incident. **H24-00601**

<u>Towed Vehicle/Unlicensed Driver:</u> On July 3, 2024 at 9:12 PM an Officer conducted a traffic stop on Honda Civic. The 22 year old male driver was determined to be unlicensed. The 24 year old male passenger was also determined to be unlicensed. The registration for the Honda has been expired for over 6 months and 1 day. It was towed for the registration violation. The driver was cited and released for driving while unlicensed. **H24-602**

Possession of controlled substance for sales/Warrant Arrest: On July 4, 2024 at 3:07 AM an Officer conducted a vehicle check on a Chevrolet Tahoe at 76 Gas. While contacting the occupants, the Officer observed drug paraphernalia in plain view. All three subjects; a 38 year old male; a 49 year old male; and a 46 year old male; were detained without incident A records check showed 38 year old was on Placer County probation. The subject also had two no bail warrants, one for probation violation out of Placer County S.O. and the other for theft charges out of UC Davis PD. A probable cause search of the vehicle was conducted. Multiple baggies containing suspected controlled substances, along with a scale, were located inside the vehicle. All three occupants were arrested. The 38 year old was arrested for his outstanding warrants. The 49 year old was arrested for possession of a controlled substance for sales. The 46 year old was arrested, cited, and released for possession of a controlled substance. H24-00603

<u>Warrant Arrest:</u> On July 4, 2024 at 9:25 AM an officer conducted a traffic stop on a black Kia Optima. The 65 year old female driver, from San Pablo, had a citable warrant from Yuba

County which was confirmed. The subject was arrested, cited, and released on scene. **H24-00604**

<u>Missing Person Locate:</u> On July 4,2024 at 3:44 PM an officer checked on a black Ford F-150 parked in the BART Lot at 1375 Willow Avenue. The 46 year old male driver, from Vallejo, had been reported missing to Vallejo PD. The subject appeared to be in good health and family was contacted. The subject was released and removed from the Missing and Unidentified Persons System. **H24-00605**

<u>Coroner's Case:</u> On July 4, 2024 at 4:14 PM officers responded to the 200 block of Apollo for an unresponsive male where family had begun CPR. Officers arrived and continued to perform life saving measures, but it was unsuccessful. Time of death was called at 4:25 PM. The subject was identified as 44 year old male from Hercules. Contra Costa Coroner was contacted and arrived to take possession of the body. **H24-00606**

Evading/Possession of a Loaded Firearm: On July 4, 2024, at a8:12 PM, an Officer attempted a traffic stop on a GMC Yukon in the area of Hawthorne Dr/ Vaqueros Ave for vehicle code violations. The GMC failed to yield to the Officers lights and evaded on Vaqueros Ave towards the Bayo Vista Housing. The Officer observed a solo occupant driver and could identify him. The Officer cancelled the enforcement stop upon recognizing the GMC was fleeing at a high rate of speed. The Officer believed the GMC would remain in the area and conducted a search in the area, with the assistance of CCSO. The Officer located the GMC on California St/ Mariposa St. A traffic stop was conducted. The driver exited the vehicle and attempted to walk away. CCSO Deputies assisted in detaining the 23 year old male driver, of San Pablo. A loaded revolver was located on his person. A record check revealed the gun to be registered to the subject. The GMC was towed on scene and the subject was arrested. He was later cited and released on his promise to appear. Case H24-00607

Missing Persons Locate/Warrant Arrest: On July 5, 2024, at 2:25 AM, an Officer conducted a traffic stop on a 2008 Honda Accord. A 17 year old male passenger, of Stockton, was contacted and found to have a no bail Probale Cause Warrant issued by CCSO. The subject was also listed as a missing juvenile out of Stockton. The subject was arrested on the warrant and transported to Juvenile Hall. The subject was removed from Missing and Unidentified Persons System.

<u>Vandalism</u> On July 5, 2024 at 10:04 AM officers were dispatched to Burger King at 844 Willow Avenue. The manager advised a unknown adult male threw a railroad tie through one of the panel windows facing Willow Avenue. The subject was wearing a blue puff jacket with dark jeans, and last seen on foot towards Viewpointe. The manger said the suspect never came inside the restaurant and there had been no altercations with customers. **H24-00609**

<u>Warrant Arrest:</u> On July 5, 2024, at approximately 9:06 PM, an Officer conducted a traffic stop on a black 2006 Honda Accord. The 24 year old male driver, of Oakland, was found to have a cite-releasable warrant, for firearm charges, issued out of Alameda County. The subject was arrested, cited, and released on his promise to appear. **Case H24-00610**

<u>Miscellaneous:</u> On July 6, 2024 at 11:33 AM officers responded to teh100 block of Brenner for an altercation between a 54 year old male and his 25 year old wife. It was determined no crime had occurred, and a report was taken to document the incident and confirm there was no physical altercation and no injuries. **H24-00611**

<u>Towed Vehicle:</u> On July 6, 2024, at 10:26pm, an officer conducted a traffic stop on a vehicle with obstructed license plates at Safeway Gas. A record check on the vehicle revealed the registration was expired since 2022. The 32 year old male driver had a suspended driver's license status in need of service. The subject was issued a license suspension notice and the vehicle was towed. **H24-00612.**

<u>Mental Health Evaluation:</u> On July 6, 2024, at 11:15pm, officers were dispatched to 1100 block of Cottage Lane for a report of an older male subject who appeared disoriented and walking in the middle of the street. Officers located the subject in the Alley by Titan Way. The subject was determined to a danger to himself. He transported to the Contra Costa Regional Medical Center by AMR for an Evaluation. **H24-00613.**

<u>Solo Vehicle Collision:</u> On July 07, 2024, at 5:44 pm, Officers were dispatched to the 1700 block of Redwood Road for the report of a male that hit a parked car. Officers located an 85 year old male, sitting in the driver seat of his silver 2008 Honda Accord. The subject was driving eastbound on Redwood Rd. when he apparently experienced a medical emergency. This caused the Honda to collide into a silver 2019 GMC Sierra, which was parked along the curb. The subject was transported to a hospital and the Honda was towed. <u>H21-00614</u>

Shoplifting / Warrant Arrest: On July 7, 2024, at 7:33pm, officers responded to a report of a theft from Rite Aid involving a male adult. The subject fled in a gray Ford Flex (license number reported) WB on Sycamore Ave. An officer located the vehicle getting on EB I80 from John Muir Pkwy and initiated a traffic stop. The vehicle yielded on the onramp. All 3 occupants of the vehicle were detained. Records checks revealed the front 29 year old male passenger, out of Vallejo, was wanted on a Felony No Bail warrant out of Napa County for retail theft. An In-Field show was conducted and the 28 year old male rear passenger, out of Vallejo, was identified as the one responsible for the theft of 4 cases of Red Bull. A Rite Aid hand basket which was located in the back seat of the vehicle. The 28 year old was arrested, cited, and released. The items, totaling \$161.94, were returned to Rite Aid. The 29 year old was arrested for the warrant and was transported to the Martinez Detention Facility. A receptacle containing suspected heroin was located on his person, by the Deputies. It was suspected the subject had more contraband in his person, and he was medically rejected at the jail. The subject was medically cleared at the Contra Costa Regional Medical Center and returned to the jail. H24-00615 / H24-00616.

<u>Warrant Arrest:</u> On July 7, 2024, at 11:54pm, an officer conducted a traffic stop on a vehicle on Willow Ave over Highway 4. A record check on the occupants revealed 39 year old female passenger, of Richmond, had a Felony No Bail Warrant out of Contra Costa County for probation violations, and a Felony \$30,000 Warrant out of Santa Clara County for Failure to Appear. The subject was arrested and transported to the Martinez Detention Facility where she was booked without incident **H24-00617**.

<u>Mental Health Evaluation:</u> On July 8, 2024, at 2:31am, officers were dispatched to Amber Ct. for a report of a known subject with mental health issues slamming doors and breaking glass. Officers were able to call out the subject from his residence and detain him without incident. Based on the subject's actions he was determined to be a danger to himself and others and transported to Contra Costa Regional Medical Center by AMR **H24-00618**.

<u>Warrant Arrest:</u> On July 8, 2024, at 8:58 am, an Officer conducted a traffic stop on a black 2003 GMC Yukon, in the area of Willow Ave and San Pablo Ave, for multiple vehicle code violations. The 24 year old male rear passenger, from San Francisco. was determined to be on California Department of Corrections Parole for robbery. A record check also revealed the

subject had an active no bail felony warrant for a parole violation issued February 28, 2024. The subject was taken into custody and transported to the Martinez Detention Facility for the warrant. **H24-00619**
