Warrant Arrest: On July 10, 2024, at 9:22 PM, an Officer conducted a traffic stop on a 2020 Honda Accord. The 22 year old male driver, of San Leandro, was found to have an outstanding juvenile warrant for his arrest. The subject was arrested and transported to Juvenile Hall. The Honda was released to the passenger. **Case H24-00627**

Warrant Arrest: On July 10, 2024, at 11:15 PM, an Officer conducted a traffic stop on a 2006 Toyota Camry. A 24 year old female passenger, of Richmond, was found to have an outstanding felony warrant, for theft charges, out of Campbell PD. The subject was arrested, cited, and released on scene. **Case H24-00628**

Outside Assist for a Hit & Run: On July 11, 2024 at 11:24 AM Contra Costa County Deputies asked for cover in the area of Dover and Cambridge. Officers arrived and assisted County Units with a hit and run related to an incident involving an assault with a deadly weapon. The 31 year old male suspect, from Rodeo, fled the 700 block of Windward Drive, in Rodeo, The suspect was later located by County units and arrested for the incident that occurred in Rodeo. **H24-00629**

Possession of a Loaded Firearm/Not Registered Owner: On July 11, 2024, at 11:33 PM, an Officer conducted a traffic stop, on a Bronze 2016 Buick Verano, on Turquoise Dr and Jasper Ct. The Officer contacted the occupants and observed various Marijuana violations. A 25 year old male, of Hercules; a 25 year old female, of Hercules; and a 24 year old male, of Richmond, were removed from the vehicle. A probable cause search was conducted. A backpack, which was previously in between 25 year old male's legs, contained a loaded pistol, with an extended magazine. Indicia for the 25 year old male was located in the backpack. The pistol was registered to a Brentwood resident but was not reported stolen. Multiple attempts to contact the register owner were unsuccessful. The 25 year old male was arrested and transported to HPD. The other two occupants, and the vehicle, were released on scene. The subject made spontaneous statements, while at HPD, which lead officers to believe he may be a danger to himself. AMR responded to HPD and took the subject for a Mental Health evaluation. A "notification prior to release" was requested. The subject will be booked at the Martinez Detention Facility when he is authorized for release from the hospital. **Case H24-00630**

Possession of a Loaded Unregistered Firearm: On July 12, 2024, at 12:35 AM, an Officer conducted a traffic stop on a no plate, black Kia Optima on John Muir Parkway/ Alfred Nobel. The Officer contacted the 26 year old male driver, of Vallejo. The Officer observed an open bottle of alcohol and observed DUI indicators. As the Officer was removing the subject from the vehicle to conduct a Standard Field Sobriety Test, he observed a black firearm in the vehicle. It was next to the subject's leg, between the door and seat. The subject was detained, and a loaded pistol was recovered. There was no registration information on file.

The subject was uncooperative with any further DUI investigation. He was arrested and booked at the Martinez Detention Facility for the firearm charges. **Case H24-00631**

Mental Health Evaluation/ Warrant Arrest: On July 12, 2024, at 2:53 AM, Officers were dispatched to the area of the 300 block of Sparrow Dr for a report of an Uber driver and passenger issue. Officers arrived on scene and contacted 35 year old female, of Santa Rosa. The subject was found to have two outstanding warrants, out of Petaluma PD, for traffic offenses. The subject was also determined to have mental health issues. She was transported to the Contra Costa Regional Medical Center and cited and released on her outstanding warrants. **Case H24-00632**

Domestic Violence: On July 13, 2024, at 12:49 AM, Officers responded to the 1300 block of Sycamore Ave for a report of a domestic disturbance. Officers arrived on scene and contacted the female victim. The victim said the 24 year old male suspect, of Hercules, had left in his 2020 Honda Civic. The victim stated she and the male had been arguing tonight. She advised two days ago the male physically assaulted her resulting in injury. The victim had visible injuries that appeared consistent with her timeline. The victim did not request an Emergency Protective Order. **Case 24-00633**

Found Property: On July 13, 2024 at 9:26 AM a local citizen arrived at HPD to turn in a found Apple iWatch. The watch was found in the area of Santa Fe and Fawcett. The watch was booked into evidence for safekeeping. **H24-00634**

Attempt Robbery/Warrant/False Impersonation: On July 13, 2024 at 3:28 PM officers were dispatched to Taco Bell at 1541 Sycamore Avenue for an adult male who had reportedly stolen a blue mountain bike from a group of juveniles. While enroute officers were flagged down at Safeway Gas where the victim (juvenile) had recovered his bike. The juvenile stated the suspect had taken the bike and fled. The Juvenile followed the suspect, on another bike, and caught up with the suspect. The suspect attempted to strike the juvenile with the stolen bike, then fled on foot. After receiving the description of the suspect officers located the 34 year old male subject, from Richmond, He was near San Pablo Avenue and John Muir PKWY to the rear of Safeway. The subject was safely detained and arrested. The subject initially identified himself as his brother, but later his true identity was established. The subject also was found to have a felony warrant out of San Jose for burglary. The suspect was positively identified by the victim. The victim's father arrived on scene and stayed with the juvenile. The subject was transported to the Martinez Detention Facility **H24-00635**

Sideshow Activity/Towed Vehicle: On July 13, 2024, at 10:20 PM, Officers responded to the Franklin Canyon Rd off ramp area of westbound Highway 4 for a large sideshow of 50+ vehicles. CHP Contra Costa arrived and began dispersing vehicles. Officers assisted CHP Contra Costa in dispersing the large gathering. Two vehicles from the sideshow entered the Franklin Canyon Golf Course parking lot. Hercules Officers blocked the exit and entrance to the parking lot. One vehicle, a gold Toyota Tacoma, continued eastbound into the brush off-roading near Christie Rd. Officers did not follow. The second vehicle, a 2005 Ford Mustang, surrendered to Officers. The occupants were a 20 year old, of Hayward, and a 17 year old, of Hayward. Neither subject had a valid driver's license. The Mustang was towed. The 20 year old was cited for driving while unlicensed, as Officers did see the subject driving on a public highway. Later, the Toyota was located, abandoned, behind the Highway 4 guard rail near Christie Rd. The vehicle was stuck, based on a large ditch blocking its escape. No occupants were seen or contacted. CHP Contra Costa towed two vehicles from this event as well. **Case H24-00636**

Warrant Arrest: On July 14, 2024, at 3:13 pm, an Officer conducted a traffic stop on a 2024 Honda Accord at 828 Willow Ave for vehicle code violations. The 23 year old female driver, of Antioch, was found to have an active, cite-releasable, misdemeanor arrest warrant out of Contra Costa County for theft. The subject was subsequently placed under arrest for the warrant. She was issued a court new date and was released. **H24-00637**

Warrant Arrest: On July 15, 2024, at 03:03AM, an Officer conducted a vehicle check on a 2002 Ford F-150. A 23 year old male occupant, of San Pablo, was found to have an outstanding no bail felony warrant for probation violation out of Marin County. The subject was subsequently placed under arrest for the warrant and transported to the Martinez Detention Facility without incident. **H24-00638**
