Abandoned Vehicle: On August 8, 2024, at 10:43 AM, a parking enforcement officer located and towed a prior tagged, abandoned, and expired BMW parked on Midship Drive. **H24-00708**

Vehicle Accident: On August 8, 2024, at 4:10 PM, officers were dispatched to Sycamore Ave and Turquoise Drive for a vehicle collision involving an ambulance, which was enroute to a medical emergency. The ambulance was travelling through the intersection when another vehicle pulled in front of the ambulance. No injuries were reported. **H24-00709**

Occupied Stolen Vehicle: On August 8, 2024, at approximately 7:24 PM, Officers received a notification of a stolen 2022 Toyota Prius traveling eastbound I-80 at Appian Way. Officers located the Prius on eastbound Highway 4 at Franklin Canyon Golf. A high-risk stop was conducted on eastbound Highway 4 at Cummings Skyway. A 36 year old male of Texas along with 4 other family members were detained. Investigation revealed that it was a rental car error, and the driver received the wrong car key at the fault of the company. All occupants were released on scene and the Prius was towed. **H24-00710**

Loaded Firearm in Vehicle/Public Place: On August 8, 2024, at approximately 10:27 PM, an Officer attempted to conduct a suspicious vehicle check on a Black SRT Jeep, backed in at Jack in the Box, accompanied by a Black Mercedes AMG sedan, backed in. As the Officer exited his patrol vehicle, The Mercedes, occupied by 4, fled from the parking lot at a high rate of speed. The Officer attempted to catch up to the Mercedes to retrieve a license plate as it fled on westbound I-80 but was unsuccessful. Officers went back to Jack in the Box and found the 2012 SRT Jeep. The Jeep was unoccupied and unlocked, parked crooked in a parking space. Based on the total circumstances and community caretaking of an unlocked vehicle, Officers believed the Jeep was possibly an unreported stolen vehicle. Officers attempted to locate contact information for the Registered Owner (RO), 26 year old male of San Jose, inside of the Jeep. Inside the center console was a pistol. The pistol was found to be registered to the Jeep's RO. Officers were able to get in contact with the RO who stated the vehicle is not stolen and he parked it there. The pistol was taken as evidence and the Jeep was left on scene and locked by Officers. **H24-00711**

Warrant Arrest: On August 9, 2024, at approximately 1:25 AM, an Officer conducted a pedestrian stop on 38 year old male, local transient. The subject had a cite and releasable warrant for his arrest issued by Ripon PD. The subject was released on his promise to appear. **H24-00712**

Shoplifting: On August 9, 2024, at 10:12 AM, an officer was conducting a security check of Rite Aid, the officer witnessed a female steal items from the business and then walk out of the store without attempting to pay for the items. The officer located the female outside and she was detained without incident. The female was identified as a 36 year old female out of

Oakland. The subject (SUB) had property concealed in a backpack from Rite Aid and Lucky. Rite Aid wished to press charges for the theft and Lucky only wished to have her trespassed from the business. SUB was cited and released on her signed promise to appear and was served with Trespass paperwork for Lucky. **H24-00713**

Towed Vehicle: On August 9, 2024, at 10:44 AM, an officer towed a vehicle from the parking lot of Safeway at 4080 San Pablo Ave. The vehicle, Gray 2012 Nissan Sentra, was abandon and had not moved in over two weeks. **H24-00714**

Warrant Arrest: On August 9, 2024, at approximately 8:21 PM, an Officer conducted a traffic enforcement stop on a 2014 Lexus Sedan for vehicle code violations. A 30 year old male subject (SUB 1), of Vallejo, and 21 year old female subject (SUB 2), of Hercules, were contacted. SUB 2 was found to have a non-citable release warrant for her arrest issued by San Francisco PD. SUB 2 was transported to Martinez Detention Facility. **H24-00715**

Resisting/Delaying/Obstructing Peace Officer/Warrant Arrest: On August 9, 2024, at approximately 11:28 PM, an Officer conducting a security check of The Exchange observed a subject (SUB) riding a bicycle on Bayfront Blvd. SUB was wearing a hooded sweater and gloves while carrying a large object. The Officer attempted to detain SUB for vehicle code violations observed on his bicycle. SUB continued on the bay trail refusing to stop for the Officer. Eventually on Trestle Cove SUB began fleeing from the Officer and refusing commands to stop. SUB fled through Victoria Park where the Officer engaged in a foot pursuit of SUB. The Officer caught up with SUB and was able to get him off the bicycle. SUB refused to identify himself for an extended period of time. SUB declined medical care and did not have visible injuries. Eventually the 41 year old male, transient of Vallejo, identified himself. SUB was found to have a no cite warrant for his arrest issued by Vallejo PD. SUB was taken into custody for 148(a) PC and his outstanding warrant. SUB was taken to Martinez Detention Facility. **H24-00716**

Miscellaneous Information: On August 11, 2024, at 5:52 PM, officers were dispatched to the 200 block of Meadowlark Way for a battery that had just occurred and the suspect left. Officers arrived on scene and contacted the victim and the witness. The witness stated she hired a worker who got into an argument with the victim. The worker hit the victim in the head. The story was not able to be corroborated and there was no evidence of the victim being hit. Case taken for Information only at this time. **H24-00718**
