**Prisoner Transport (Warrant):** On August 15, 2024 at 10:09 AM the Parking Control Officer picked up a 33 year old male, from the Santa Clara County Jail. The subject was arrested on a Hercules Warrant and transported to the Martinez Detention Facility. **H24-00726**

**Theft:** On August 15, 2024 at 10:42 AM an officer responded to the Glenwood condo complex for a theft of a bicycle. The theft occurred sometime between August 11/12 at midnight. The bicycle is a black mountain bike with "TREK" decals on both sides of the frame in lime green. **H24-00727**

**Theft:** On August 15, 2024 at approximately 1:50 PM, a citizen parked her unlocked vehicle in the west parking lot of the Hercules Pet Clinic. When she returned, approximately 10 minutes later, her backpack purse was missing from her front seat. Her backpack has dog print with black, brown and beige colors. **H24-00728**

**Towed Vehicle:** On August 15, 2024, at approximately 8:40 PM, an Officer located a 2004 Ford Taurus parked, unoccupied, at Safeway. The Ford had a 2023 registration tab on the rear license plate but was last registered in 2019. The Ford was towed for the registration violation, and false tag. **Case 24-00729**

**Possession of a Zip Gun/Addict Possessing Ammunition:** On August 16, 2024, at 2:27 AM, an Officer was behind a vehicle on Parker Ave about to conduct a traffic stop when a 2009 Kia sedan drove up behind the Officer's patrol vehicle, at a high rate of speed. The Kia sped around the Officer's patrol vehicle and turned right onto First St from Parker Ave and ran the stop sign on First St at Railroad. The Kia then abruptly pulled over on Railroad Ave at Mariposa St. The 42 year old female driver, of Rodeo, attempted to exit the vehicle. The Officer conducted a traffic stop, on the Kia, for various Vehicle Code violations. While speaking with the driver, the Officer observed a flare gun on the driver's floorboard. The Officer safely detained the subject. The Officer located a 12 Gauge Flare Gun along with 12 Gauge ammunition. The subject admitted to owning the Flare Gun and Ammunition. She said she did not own any Flares for the Flare Gun. The subject was arrested and taken to HPD. The subject advised she smokes Methamphetamine daily and has done so for the past five years. The subject was later cited and released on a promise to appear. **Case 24-00730**

**Collision/Drug Possession:** On August 16, 2024 at 7:58 AM officers responded to the 300 block of Violet Road for a vehicle collision. Officers found a gray 2007 Audi Q7, blocking Violet Road at Marigold, with major front-end damage. The Audi had collided with a white BMW sedan which was parked in front of a residence. The force of the collision caused the BMW to collide with two other vehicles parked in the driveway of the residence. The driver and only occupant of the Audi was identified as a 46 year old male, from Antioch. The subject was found to be in possession of suspected Percocet and suspected methamphetamine. The

subject was arrested and released, with a cite on scene, and transported to a local hospital. **H24-00731/H24-00732**

**Towed Vehicle:** On August 16, 2024 at 10:32 PM a white Honda Accord was found parked at Hercules Avenue and San Pablo Avenue. The vehicle had not been moved for over 72-hours. The vehicle was towed. **H24-00733**

**Lewd Acts with a Child** On August 16, 2024 at 3:12 PM an officer received a call from hospital in San Francisco. The staff member advised a 13 year old patient reported being touched sexually by a family member. The incident reportedly occurred, in Hercules, a year ago. The officer with follow-up on this case. **H24-00734**

**Possession of a Loaded Firearm:** On August 16, 2024, at 9:48 PM, an Officer conducted a traffic stop on a 2018 Infiniti Q50S. The vehicle's registration expired in November of 2023. The 23 year old male driver, of Vallejo, was the sole occupant of the vehicle. The vehicle was towed for the registration violation. During an inventory search, a crossbody bag was located on the back passenger area. Inside of the crossbody bag was a fully loaded handgun with an extended magazine. The subject was detained. A records check revealed the handgun was registered to the subject. The subject was arrested, cited, and released. **Case 24-00735**

**Stolen Vehicle:** On August 17, 2024 at 12:18 PM Officers were informed Los Gatos PD had located an unreported stolen vehicle, from Hercules, in their jurisdiction. The vehicle was a White Farmall Dump Truck. The truck had been parked at the end of Skelly, in Hercules, in the construction sites. The truck belongs to Hudson Excavation. The owner was contacted and reported the truck stolen. Los Gatos PD then recovered the vehicle and released it to an employee from the excavation company. **H24-00736**

**Shoplifting:** On August 17, 2024 at 4:41 PM officers responded to Rite Aid at 1560 Sycamore Avenue for a report of a male adult, wearing all black, stealing items from the store. The suspect fled into a blue Ford Expedition and was last seen travelling into Creekside. Officers circulated and were unable to locate the vehicle or the subject. **H24-00738**

**Domestic Violence:** On August 18, 2024, at 6:00am, officer responded to the 100 block of Sunflower Ct. for a report of an estranged ex-girlfriend, of the adult male victim, attempting to break into the residence through the bedroom window. Upon arrival, officers located the 23 year old female suspect in the backyard and detained her without incident. Victim stated the suspect pushed out the window stop from the partially open window, tore through the shades and hit him in the side of the face multiple time. An Emergency Protective Order was granted for the Victim. The suspect was arrested and transported to the Martinez Detention Facility. **H24-739.**

**Vehicle Collision into multiple cars and multiple houses.** On August 18, 2024, at 2:57 pm, officers were dispatched to a vehicle into a structure in the 100 block of Gardenia Loop. Officers arrived on scene and contacted the 65 year old female driver, of Hercules. The subject backed into her own garage then exited her driveway at a high rate of speed coming to rest in a neighbor's driveway, two doors down, after colliding into her other vehicle. The subject also collided into a neighbor's truck, a Tesla parked in the garage, and the House, for a total of six area of impacts. The subject was transported to a hospital by AMR for evaluation. **H24-00740**

**Theft / Unauthorized use of access cards:** On August 18, 2024, at 7:43pm, officers responded to City Hall to meet with an adult female regarding her wallet and cash being

stolen out of her purse on August 17, 2024. The victim stated she was shopping at Safeway, at approximately 6:00pm, and had her purse located on the bottom of her cart. The victim stepped away from her cart momentarily to answer a question for another patron. When she went to pay, she noticed when she went to pay that her wallet was missing. Shortly after leaving Safeway, she began receiving fraud alerts from her financial institutions due to someone attempting to use her credit cards. The victim was able to decline almost all transaction except for Best Buy and Home Depot. **H24-00741.**
