Natural Death: On August 23, 2024, at 12:03 PM officers responded to Jade Court for an unresponsive female not breathing. Officers arrived and found an 82 year old female laying on the ground. CPR was immediately performed, and a defibrillator was connected to the subject. Rodeo-Hercules Fire District and AMR arrived on scene and took over the life saving measures which were not successful. The coroner was contacted, and the body was released to the family. A Chaplin arrived on scene to assist with the family. **H24-00754**

Recovered Stolen Plates/Stolen License Plates: On August 23, 2024, at approximately 8:16 PM, Officers received a Flock notification for two lost/stolen license plates, reported on today's date to Vallejo PD, attached to a black Mercedes SUV. An Officer located the Mercedes on Bayfront Blvd. The Officer conducted a traffic enforcement stop and contacted a 58 year old male subject of Hercules. The subject was found to be a victim of having his license plates stolen and these stolen plates placed on his Mercedes. The victim did not know this occurred and did not last recall when he saw his license plates. A courtesy report was taken for his stolen license plates and the two on his vehicle were recovered. **H24-00755**

Outside Assist: On August 23, 2024, at approximately 11:19 PM, Vallejo PD had a sideshow of approximately 200 plus vehicles in their city. Vallejo PD pursued a Cadillac CTS sedan into Hercules, and the sedan was involved in a solo collision on San Pablo Ave at John Muir Parkway. 4 occupants foot bailed from the vehicle. 3 occupants were caught after Vallejo Officers chased after them on foot. The driver fled into the Marsh area on San Pablo Ave. Hercules Officers along with Vallejo PD, Contra Costa Sheriff Office, Richmond PD K9 and CHP Air set a perimeter around the marsh. The driver was eventually apprehended after surrendering to K9 announcements. **Incident # 2408230221**

Felony Evading: On August 24, 2024, at approximately 1:58 AM, Hercules Officers/CCSO/CHP were now dealing with the above mentioned 200 plus vehicle sideshows. The sideshow was occurring in Crockett with multiple vehicles dispersing throughout the Rodeo/Hercules area. An Officer observed a 2008 white Honda Accord on Sycamore Ave at Willow Ave. The Officer attempted a traffic enforcement stop on the Honda as it entered onto westbound I-80 from John Muir Parkway. The Honda turned its lights out and began to flee at a high rate of speed onto westbound I-80. The Officer initiated a brief pursuit while waiting for a records return on the Honda. The Honda was found to be clear of any Felony wants and nothing further than traffic violations were observed. The Officer discontinued the brief pursuit westbound I-80 passing Pinole Valley Road. During the short pursuit the Honda committed an excess of 3 vehicle code violations. The Honda was occupied by two unknown males. **H24-00756**

Domestic Violence: On August 24, 2024, at 3:50 PM officers responded to Jacaranda Court regarding the husband of the Reporting Party/Victim (RP/V) physically attacking her. The husband was identified as a 35 year old male subject (SUB) of Richmond. RP/V, 35 year old

female, advised officers SUB had grabbed her by her neck and slammed her against the wall. Officers contacted SUB and detained him without incident in front of the house. There were two children in the house that were rendered safe. SUB was arrested and transported to Martinez Detention Facility. **H24-00758**

Brandishing Firearm: On August 24, 2024, at approximately 6:43 PM, Officers received a phone detail regarding an ongoing dispute between the victim (V), 29 year old female, and a 42 year old male subject (SUB) over a vehicle and one party being evicted from a shared apartment. During the phone detail with V, she stated that over a month ago, SUB pointed a firearm at her while they were in their bedroom together. Officers contacted SUB over the phone who denied this accusation. **H24-00759**

Outside Assist/Vehicle Collision: On August 25, 2024, at 9:10 AM, Dispatch advised HPD units that a Contra Costa County Sheriff Office (CCCSO) Deputy was in pursuit of a red truck in the area of Pheasant Drive at Swallow Way. Dispatch advised the vehicle drove into Country Run where it finally yielded in the area of Valley Run and Peak Court. Upon yielding Dispatch advised of a foot bail. HPD units assisted the Deputy in detaining the suspect. The Ford Explorer the suspect ran from had proceeded to roll forward, eastbound, on Valley Run. It came to a stop when it collided into a 2-foot-tall wooden landscape retaining wall, located at the corner of Valley Run and Plateau Court. Upon arrival of additional CCCSO Deputy's the vehicle was cleared, and it was determined there were no other occupants in the vehicle or outstanding suspects. A case was taken for the vehicle collision. **H24-00760**

Outside Assist/Child Abuse: On August 25, 2024, at 8:21 PM, officers contacted the mother of a 5-year-old daughter regarding a report of child abuse that occurred in Hercules. The Reporting Party stated she noticed her daughter had a bruised and swollen upper lip after picking her up at a custody exchange with her father. When asked, the daughter stated her father hit her in the mouth because he was frustrated when he could not find his phone. The mother stated it occurred at her ex-husband's home in Hercules and he has a history of domestic violence against the mother. After taking all information and statements from both mother and daughter, the mother stated she was not positive that the father was still living in Hercules and could now possibly living in Oakland. Officers responded to the Hercules address to conduct records checks on all vehicles parked in the driveway which returned to a different last name than the father. Oakland PD was contacted and was able to confirm two of the vehicles known to be operated by the father were parked at the address and a records check revealed him to be the registered owner of one. Case taken to be forwarded to Oakland PD. **H24-00761**

Stolen Vehicle: On August 26, 2024, at 4:27 AM, officers were requested by Richmond PD to contact the Registered Owner (RO) of a blue Dodge Charger, at Lookout Court, and inquire if he knew his vehicle's whereabouts. Richmond PD advised they found the vehicle unoccupied, and their Reporting Party observed 4 subjects who appeared to be stripping parts off it. Officers made contact with the RO who stated his vehicle was supposed to be parked in his driveway and it was last seen when his brother arrived at his residence at approximately 2:00 AM. Hercules officers took a stolen vehicle report for the RO but when Richmond was re-contacted, they stated the vehicle was now gone. **H24-00762**
