**Stolen Vehicle/Fleeing:** On August 29, 2024, at 4:50 PM officers received a FLOCK and ALPR notification of a stolen vehicle, brown 2018 Toyota Camry, coming into Hercules. An officer located the vehicle turning onto Partridge Drive and deployed stop sticks, which were successful. The suspect continued and fled from the vehicle into the front yard of a home on Partridge Drive. A perimeter was set, and assistance was provided by surrounding agencies with a K9 and Drone. The suspect was not located, and the vehicle was recovered and released to the victim's friend. The vehicle was removed from the Stolen Vehicle System.

**Evading/Recovered Stolen Vehicle:** On August 30, 2024, at approximately 12:28 AM, Officers received numerous FLOCK notifications for a stolen license plate attached to a BMW i3 driving around the city with no lights on. Officers located the BMW with the attached stolen license plate as it entered onto westbound I-80 from John Muir Parkway. Officers attempted a traffic enforcement stop on the vehicle. The BMW fled from Officers at a high rate of speed and the Officers discontinued their pursuit. As Officers were going back into city limits, they observed the BMW enter back into Hercules, taking the Hercules off-ramp from eastbound I-80. Trailing from afar, Officers observed the BMW enter the Village Parkway area. Officers flooded the area with a spike strip. Approximately 10 minutes later, an Officer located the BMW parked at the dead end of Scotts Valley, unoccupied. A record check of the VIN revealed the BMW was an outstanding stolen vehicle reported to Berkeley PD on 08-26-2024. Hercules Officers along with Pinole PD and San Pablo PD K9 searched the area but were unable to locate any possible suspects. The vehicle was towed. **H24-00774**

**Warrant Arrest:** On August 30, 2024, at 2:13 PM officers contacted a 37 year old male at Ridgepoint Court regarding an active warrant. The subject was arrested without incident and cited and released with a new court date. **H24-00776**

**Mental Health Evaluation:** On August 30, 2024, at approximately 7:33 PM, Officers were dispatched to Knoll Court for a disturbance. Officers determined that a 27 year old female was a danger to others. AMR arrived and transported the subject to the Contra Costa Regional Medical Center for an evaluation. **H24-00777**

**Prowling:** On August 31, 2024, at 8:58 AM an officer responded to the 100 block of Overlook Terrace regarding a 30 year old female subject (SUB) from Richmond. The Reporting Party/Victim advised SUB had been going to multiple houses in the area attempting to get inside them. She was checking door handles, looking for keys under mats, and trying various keys. **H24-00778**

**Negligent Dog Owner:** On August 31, 2024, at 10:30 AM officers responded to the 300 block of Pepperwood Street for two aggressive rottweilers who just killed a small dog and bit the owner of the dog, 77 year old female victim. The victim stated the dogs were running

loose in the neighborhood. The dogs were located on Redwood Road and cornered in a front yard on Fir Court. Animal Control arrived and took custody of the two large rottweilers. Officers acquired the owner's address and contacted the owner, 43 year old male of Hercules. The subject was cited and released on scene for being a negligent owner of two aggressive dogs. The dogs also had no identifying tags or collars. **H24-00779**

**Stolen Vehicle:** On September 1, 2024, at 11:39 PM, an officer responded to the 300 block of Sparrow for a stolen vehicle report. The victim stated at 11:03 PM he observed his 2008 Cadillac Escalade leaving his driveway on his surveillance camera. A check on FLOCK revealed it was last captured traveling in Vallejo near the time of call. **H24-00781**

**Auto Burglary:** On September 2, 2024, at 8:14 AM, an officer was dispatched to Aralia Court for a reported vehicle that had been vandalized and broken into. The victim stated his Blue 2007 Honda Civic had most of the windows broken out and a laptop stolen from inside the vehicle. This occurred sometime overnight. **H24-00782**

**Felon in Possession of Firearm:** On September 2, 2024, at 9:15 AM, an officer located a subject sleeping near the freeway overpass on Sycamore Ave. The officer contacted a 60 year old male subject (SUB), out of Oakland. When SUB got up the officer located drug paraphernalia. SUB was detained and a search was conducted of his person. The officer also checked under a piece of large paper SUB was sleeping on and located a loaded unregistered firearm. SUB was also found to be a convicted felon with prior firearm related arrests. SUB was transported to HPD for an interview then transported to the Martinez Detention Facility. **H24-00783**
