<u>Towed Vehicle</u>: On September 5,2024 at 7:31 AM officers responded to the 100 block of Tanager Way. A white GMC P3500 Food Truck reportedly had been abandoned for more than 72 hours. The truck was towed. **H24-00791**

<u>Property For Destruction:</u> On September 5, 2024 an officer responded to the 100 block of Oxford Street. The reporting party wanted HPD to take possession of his late father's handgun. The gun was taken and booked into HPD evidence for destruction. **H24-00792**

A 2004 silver Lexus 4-door, which was used in a residential burglary in Crockett, was located. <u>Recovered Stolen Vehicle:</u> On September 5, 2024, at 9:03 PM, an Officer checked on a vehicle parked at Safeway. The vehicle, a Chevrolet Tahoe, was observed unoccupied and had ignition damage. The Officer contacted the registered owner, of Vacaville. The owner advised his Tahoe had been stolen and he was unaware. The owner contacted Vacaville PD and made a stolen vehicle report. The Tahoe was then removed from SVS and towed. **Case 24-00794**

<u>Residential Burglary:</u> On September 5, 2024, at 10:53 PM, Officers responded to a call of a residential burglary in the 1100 block of Promenade. St. Officers contacted the reporting party. She stated she arrived home around 9PM and found her back door kicked in. It appeared the residence had been looked through/ drawers open. The loss is undetermined at this time. **Case 24-00795**

<u>Outside Assist:</u> On September 6, 2024 at 7:17 AM officers received a flock notification of a gray 2004 Dodge Durango entering the City. The Durango was involved in various copper thefts from AT&T, and a notification had been sent out by Moraga PD. The suspects had caused considerable loss, and damage, committing the thefts. Officers located the vehicle in the Home Depot parking lot at 1625 Sycamore Avenue. Officers also identified two occupants of the vehicle. The driver was a 35 year old male, from Napa; and the passenger was identified as a 45 year old male, from Livermore. A records check of both subjects came back clear. Moraga PD was notified and only wished identification of the subjects at this time. The subjects were released at the scene. **H24-00796**

<u>Prisoner Transport</u> On September 6, 2024 at 10:12 AM our Parking Control Officer transported a 40 year old male from Santa Rita Jail to the Martinez Detention Facility for an outstanding local warrant. **H24-00797**

Towed Vehicle: On September 6, 2024, at 8:15 PM, an Officer observed a Kia Stinger, with no plates, parked in a handicap stall at 76 Gas Station. The Officer contacted a 21 year old male passenger, of Vallejo, in the vehicle. The driver, a 21 year old female, of Vallejo, exited the Rocket Mart and was contacted. A record check of the Vehicle Identification Number revealed the vehicle had no valid registration and a pending application had been received in December of 2023, but not completed. The female stated she purchased the vehicle in June of 2023 in Reno Nevada and provided a bill of sale with the date. In December of 2023 The subject attempted to register the Kia with CA DMV but did not agree with the fees and decided not to pay them. The female stated she has made no attempt to go back to DMV to register her vehicle despite receiving tickets before. The female also has no driver's license issued to her. The Kia was not registered in Nevada either. The Kia was subsequently towed for the registration violation. Case 24-00798

<u>Outside Assist:</u> On September 7, 2024, at 2:39 AM, an Officer was parked near the rear Safeway entrance/exit when they observed a vehicle exiting westbound Highway 4 at an extremely high rate of speed. Immediately the vehicle crashed into the trees located on the side of the off-ramp near the San Pablo Hilltown project. The vehicles engine was ejected from the frame of the car and caught fire in the brush. The Officer was unable to see inside of the vehicle due to the vehicle being wrapped in the trees. Pinole PD, CCSO, CHP and RHFD responded. CCSO flew a drone in the area, with FLIR, to check for any occupants who may have been ejected. None were located. RHFD cut the vehicle open, and an adult subject was located deceased inside. CHP took over the investigation. **Case 24-00799**

<u>Possession of Controlled Substance:</u> On September 8, 2024, at 9:11 am, an officer contacted a subject in the parking lot in the 800 block of Willow Ave. The 41 year old male subject, of Fairfield, was found to be on parole. A search was conducted, and suspected heroin was located in his pants pocket. The subject was arrested, cited, and released on his signed promise to appear. <u>H24-00800</u>

<u>Miscellaneous Info:</u> On September 8, 2024, at 11:13pm, officers responded to the 2000 block of Pheasant Dr. for a report of a domestic disturbance. A third-party caller claimed her 29 year old male cousin was stabbed in the face by his 31 year old female girlfriend. Officers met with the male outside the residence. He denied being stabbed, or any other domestic violence. Medics arrived on scene and treated the male for a small laceration on the bridge of his nose. Officers contacted the female at the front door. She had a laceration on her right hand but denied any involvement in domestic violence. The female was transported by AMR to receive sutures at the hospital. Case taken for documentation **H24-00803.**

Medical and Mental Health Evaluation: On September 9, 2024, at 5:25am, officers responded to Oneil Circle for a report of 93-year-old woman who called her daughter and stated she was trying to hurt herself with a knife. Officers located a female, on the bed, in her room with what appeared to be several self-inflicted lacerations. A bladed instrument was found on the floor. Officers applied torniquets to both legs to control bleeding and AMR responded for immediate transport. Officers talked with the mother's son, daughter in law and

checked the residence but did not locate any indications of foul play. Due to immediate need for transport, the Mental Health hold was not placed at this time. Officers contacted the hospital medical staff who stated based on the circumstances, they will follow through with a Mental Health evaluation. **H24-00804.**
