Lost or Stolen License Plate: On September 10, 2024, at 9:44 am, a citizen came into the lobby of the police department to report his front license plate lost or stolen. The reporting party stated, sometime between June 20th and September 7th, his California plate was either lost or stolen off his 2012 White Ford Econoline van. The plate was entered into the Stolen Vehicle System as lost or stolen. **H24-00806**

The plate was determined to be stolen and did not belong on the Civic. The plate was recovered, and it was determined the driver was unaware the plate was attached to his vehicle. Vehicle vs. Pedestrian Collision: On September 10, 2024, at 3:09 pm, officers were dispatched to Safeway for a vehicle vs. pedestrian collision in the parking lot. Officers arrived and found a 48 year old female laying in the roadway. She was conscious and awake. Video showed a 2012 Toyota, driven by a 41 year old female, was in the parking lot and was turning near the front entrance towards San Pablo Ave. The Toyota collided with the pedestrian at a low speed.
