Battery, Trespassing: On September 18, 2024, at 9:12 AM, officers were dispatched to Big Lots for a report of an aggressive subject refusing to leave the store. Officers arrived on scene and detained the subject (SUB) identified as a 47 year old male, from El Sobrante. The manager (Reporting Party/Victim-RP/V) stated that SUB had become upset about the price of an item at the store and started an argument with RP/V. RP/V advised he told SUB to leave the store. SUB refused to leave the store and according to RP/V, SUB forcefully pushed him with his chest making chest to chest contact. RP/V stated he was uninjured but did desire prosecution for battery and requested SUB be trespassed from Big Lots. SUB denied any physical contact had occurred. Follow up is being conducted. SUB was trespassed from Big Lots. SUB was also cited and released on scene. **H24-00833**

Stolen Vehicle Recovery, Warrant Arrest: On September 18, 2024, at 5:35 PM Hercules officers received a notification of a stolen gold 2007 Toyota Prius on San Pablo Avenue at John Muir Parkway. The vehicle was located parked and unoccupied in the Safeway parking lot. Hercules officers confirmed the suspect was not in the immediate vicinity and the vehicle was blocked in and recovered. As officers were processing the vehicle, a 32 year old male subject (SUB), of Richmond, began walking in the general direction of the Prius from Safeway. SUB seemed noticeably alarmed at the police presence and was promptly detained. SUB admitted to driving the vehicle and was found in possession of the ignition key and some stolen Safeway merchandise. A records check determined SUB had an outstanding warrant out of San Francisco County. SUB was placed under arrest and transported to Martinez Detention Facility. The stolen property was returned to Safeway at their request. The Prius was towed. **H24-00834**

Towed Vehicle: On September 19, 2024, at approximately 12:51 AM, an Officer conducted a traffic enforcement stop on a 2012 Chrysler Town & Country.
