Fraud: On September 26, 2024, at 9:21 AM the Reporting Party, from the 200 block of Redwood Road, arrived at HPD regarding her identity being stolen and used. An officer confirmed a crime had occurred and a report was taken. **H24-00869**

Assault with a Deadly Weapon/Threats: On September 26, 2024, at 9:26 AM officers responded to the 400 block of Sparrow Drive. The Reporting Party/Victim (RP/V), 47 year old male, stated that a 56 year old male subject (SUB) was trying to kill him. Officers arrived on scene and immediately contacted SUB. SUB was detained, and officers located the rest of the family uninjured. It was determined that SUB and RP/V were in a verbal argument which escalated when SUB grabbed a kitchen knife and attempted to stab RP/V, after threatening him. SUB was arrested and transported to the Martinez Detention Facility. **H24-00868**

Miscellaneous Information: On September 26, 2024, at 2:08 PM an officer responded to Hercules High School regarding an incident involving two juvenile males. One of the males looked over a bathroom stall while the other male was using it. School faculty had already addressed the issue and notified parents. The Assistant Principal requested it be documented by HPD. **H24-00870**

Fraud: On September 26, 2024, at 9:21 AM, the Reporting Party, from the 1000 block of N Shelter Bay, arrived at HPD regarding her identity being stolen and used. An officer confirmed a crime had occurred and a report was taken. **H24-00871**

Found Property: On September 26, 2024, at approximately 10:00 PM, an Officer was flagged down by a Contra Costa Sheriff Office Deputy regarding city property. The Deputy located a CA Exempt license plate in property left behind at an encampment, near the railroad tracks on San Pablo Ave at Pacific Ave in Rodeo. No subjects were located associated with the encampment by the Deputy. Case taken to document city property. **H24-00872**

Warrant Arrest: On September 27, 2024, at 9:10 AM an officer located a blue Chevy 1500 and conducted a traffic enforcement stop on the vehicle. The driver was identified as a 20 year old male from Pinole. The subject had an active Richmond warrant. The subject was arrested and transported to Martinez Detention Facility. The vehicle was towed. **H24-00873**

Prisoner Transport: On September 27, 2024, our Parking Enforcement Officer transported a 54 year old female from Marin County Jail to Martinez Detention Facility for a Hercules Warrant. **H24-00874**

Possession of Methamphetamine: On September 27, 2024, at 1:49 PM an officer conducted an investigative stop on a Westcat bus in the Safeway Gas Station, for a subject known to carry drugs and possibly had a warrant. Officers contacted a 60 year old male

subject (SUB) from Oakland. SUB had a no bail warrant from Cotati PD, they notified us to just advise him to appear at court. SUB was found to be in possession of suspected methamphetamine and drug paraphernalia. SUB also falsely identified himself during initial contact. SUB was cited and released on scene. **H24-00875**

Marijuana for Sales: On September 27, 2024, at 3:14 PM an officer conducted a traffic enforcement stop on a white Acura RDX on Railroad Avenue. The driver was identified as an 18 year old male from Richmond. There was a strong odor of marijuana emanating from the vehicle and other circumstances that led to a search of the vehicle. Inside the vehicle there were six pounds of suspected marijuana packaged in seven separate bags ready for sale or distribution. The subject was arrested, transported to HPD and released with a promise to appear. **H24-00876**

Stolen Vehicle Recovery: On September 27, 2024, at 6:14 PM officers received a notification for a Blue 2020 Ram 2500 that was reported stolen to CHP Contra Costa. Officers located the vehicle unoccupied at Quail Court and detained one subject associated with it. He was identified as a 42 year old male subject (SUB) from Antioch. It was determined that SUB was not responsible for the theft of the vehicle, and the registered owner had fraudulently registered the vehicle. CHP is already investigating the registered owner. The vehicle was recovered and towed, and the original victim was identified. **H24-00877**

Warrant Arrest: On September 27, 2024, at approximately 8:33 PM, an Officer conducted a vehicle check on a 2004 Chevrolet Tahoe. The Officer contacted a 45 year old male subject (SUB) of Oakland. SUB was found to have an outstanding felony warrant for his arrest. SUB was transported to Martinez Detention Facility. **H24-00878**

Felony Evading: On September 28, 2024, at approximately 12:20 AM, an Officer observed a 2021 Blue Dodge Charger traveling northbound in the 4000 block of San Pablo Ave. The Officer observed vehicle code violations. The Officer attempted to stop the vehicle as it entered westbound I-80 from John Muir Parkway. The Charger briefly yielded then fled at a high rate of speed. A brief pursuit ensued, and the Officer lost visual near Appian Way. **H24-00879**

Evading/Recovered Stolen Vehicle: On September 28, 2024, at approximately 3:42 AM, Officers received a notification for a lost/stolen license plate attached to a silver Audi A4 on Willow Ave at Cambridge. The lost/stolen plate was reported to San Francisco PD on 09-23-2024. An Officer located the vehicle, and a traffic enforcement stop was attempted on Viewpoint Blvd at Coral Ridge. The Audi fled from the Officer into Coral Ridge. The Officer disengaged from the enforcement effort and the Audi eventually fled on Willow Ave towards Highway 4. Another Officer then came to the intersection of Willow Ave at the WB Highway 4 on-ramp and observed the Audi on its roof after being involved in a solo traffic collision with the on-ramp barrier. The Officer observed three adults flee from the vehicle onto Highway 4. A perimeter was established; however, the subjects were not located. The VIN on the Audi revealed the vehicle was an outstanding stolen vehicle reported to Oakland PD on 09-23-2024. The vehicle was towed. **H24-00880**

Shooting From Vehicle: On September 28, 2024, at approximately 2:28 AM, Officers received a Gunshot Notification for multiple rounds fired in the 100 block of Worthing. At the time there was a 300 vehicle sideshow dispersing into the surrounding areas, from the Franklin Canyon area. Dispatch also received a Reporting Party stating shots were heard near Willow Ave under I-80. Officers circulated the Worthing area and nearby on Willow Ave and were unable to locate any shell casings or victims. At approximately 3:42 AM, During the above incident with the Audi, an Officer located a single spent 9mm shell casing located near

the top of the WB Highway 4 on-ramp from Willow Ave. A further area search was conducted, and a total of 10 spent 9mm shell casings were located. Officers then attributed the previous Gunshot Notification with these shell casings. The shell casings were collected. The investigation is ongoing. **H24-00881**

Warrant Arrest: On September 29, 2024, at 9:34 AM, an Officer contacted a 40 year old male of San Pablo, at the BART lot. The subject was found to have an active no bail warrant out of Contra Costa County. The subject was taken into custody for the warrant and transported to the Martinez Detention Facility without incident. **H24-00882**

Voluntary Missing Adult: On September 29, 2024, at 3:01 PM, an Officer was dispatched to the 300 block of N Wildwood for the report of a missing person. The Reporting Party (RP) reported that her ex-fiancé, 51 year old male subject (SUB), has been missing since yesterday. RP stated SUB left their home on foot at approximately 1:00 PM yesterday. RP told Officers that SUB often leaves the home and usually returns within 24 hours. However, this time he didn't return. Officers conducted an area check for SUB, and attempted to contact friends and family, but were met with negative results. SUB was subsequently entered into the Missing and Unidentified Persons System. **H24-00883**

Possession of Drugs: On September 29, 2024, at 10:25 PM, an officer conducted a traffic enforcement stop on a vehicle that left the 76-gas station and got on to WB I-80. The vehicle yielded at the Pinole Valley Road off ramp and pulled into the Kaiser parking lot. Upon contact with the driver, 48 year old male of Richmond, the officer observed drug paraphernalia. During further search of the subject and the vehicle, a small amount of suspected methamphetamine was located along with identifications belonging to other people not present. The subject was arrested and cite released upon his signed promise to appear and the vehicle was towed for registration expired more than 6 months. The officer is conducting follow up for possible identity theft. **H24-00884**

Possession of Drugs: On September 30, 2024, at 3:44 AM, an officer conducted a traffic enforcement stop on a vehicle on EB I-80 at Cummings Skyway. Upon contact, the driver, 58 year old male of Vallejo, attempted to conceal something in a baggie in front of officers. The subject was detained without incident and a bag containing suspected cocaine salt was recovered from the driver's floorboard. Further search of the vehicle did not reveal any other contraband. The subject was arrested and cite released upon his signed promise to appear. **H24-00885**
