SPECIAL EVENT ENCROACHMENT PERMIT

Special Event Encroachment Permit Conditions

- 1. Permittee shall obtain from the Public Works Division the required barricades, cones, and/or other traffic control devices. Transportation and installation of barricades shall be the responsibility of the Permittee. All barricades shall be returned by the Permittee on the first following business day during City business hours.
- 2. A copy of the encroachment permit shall be attached to barricades at each entrance to the special event area.
- 3. Access shall be available at all times for emergency vehicles and all property owners within the special area.
- 4. The City authorizes blockage of the street within the time stated on the encroachment permit or until 9:00 P.M. Activities after that time may be subject to restriction. This Encroachment Permit may be revoked at any time if the City deems the event a nuisance or hazard.
- 5. All clean up shall be the responsibility of the Permittee. Should City Personnel be required to provide any clean up; the Permittee shall be responsible for reimbursing the City for all incurred costs.
- 6. Any destruction of City owned improvements shall be the responsibility of the Permittee. This includes, but is not limited to, landscaping, lighting, street improvements, etc. Should City be required to repair any improvements; the Permittee shall be responsible for reimbursing the City for all incurred costs.
